#### FOX ENTERTAINMENT PLAZA

Construction completed in 2013 with a 12,000 sq. ft. restaurant space, a 9,000 sq. ft. exhibition space (Showcase), and a 4,000 sq. ft. black box theater (The Box)

- 1. Restaurant Space: Leased to Arteco Partners for development of Riverside Food Lab Opening in June 2018.
- 2. Showcase Space: City currently exploring various options, including development of additional restaurant vendors.
- 3. The Box: Being used for theatrical performances and concerts; losses are General Fund obligations.





#### **LEASE TERMS**

Use: Comedy club, 240 prepaid & assigned seats with food & alcoholic drinks

Premises: 4,000 sq. ft. of interior space, outdoor plaza & concession area

Lease Rate: \$5,000 per month / \$60,000 per year plus three percent (3%) annual increases

Term: 5 years with an option to extend an additional 5 years

Convert women's dressing room into a small kitchen & main bar; convert men's

TI Work: dressing room into Green Room; install new stage, furnishing, lighting &

equipment; & set up of tables, chairs and VIP booths.

Utilities: Lessee will be solely responsible for payment of all utilities.

Possessory Interest:

Lessee will be solely responsible for payment of all possessory interest taxes.

Lessee will accommodate a minimum of 25 events for short-term use at

Other Uses: reasonable rental fees for other uses outside their normal operating hours to provide a venue for artists and local groups, as well as arts education and

rehearsal space.
