

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
3 RIVERSIDE, CALIFORNIA, APPROVING A FREEWAY AGREEMENT
4 WITH THE STATE OF CALIFORNIA DEPARTMENT OF
TRANSPORTATION AND AUTHORIZING THE MAYOR TO EXECUTE
THE AGREEMENT

5 WHEREAS, State Highway 91 from Buchanan Street to Route 60/91/215 Interchange has
6 been declared to be a freeway by Resolutions of the California Transportations Commission on
7 January 20, 1954 and June 20, 1956; and

8 WHEREAS, the State of California Department of Transportation ("Caltrans") and the
9 County of Riverside ("County") have entered into a Supplemental Freeway Agreement dated
10 December 23, 1957, relating to that portion of State Highway Route 91 (old Route 43) from east of
11 East Grand Boulevard to one quarter mile west of Tyler Street; and

12 WHEREAS, the City subsequently incorporated and included certain areas from the County,
13 including portions of such freeway from Buchanan Street to one quarter mile west of Tyler Street;
14 and

15 WHEREAS, Caltrans and the City entered into a Supplemental Freeway Agreement dated
16 January 15, 1957, relating to that portion of State Highway Route 91 (old Route 43) from one
17 quarter mile west of Tyler Street to Adams Street; and

18 WHEREAS, Caltrans and the City entered into a Freeway Agreement dated July 13, 2010,
19 relating to that portion of State Highway Route 91 from Adams Street to Route 60/91/215
20 Interchange; and

21 WHEREAS, a revised plan map for such freeway has been prepared showing the proposed
22 plan of Caltrans as it affects roads of the City; and

23 WHEREAS, it is the mutual desire of the parties hereto to enter into a new Freeway
24 Agreement in accordance with the revised plan of said freeway; and

25 WHEREAS, the City has complied with the provisions of California Streets and Highways
26 Code section 100.22 by holding a public hearing on April 24, 2018.

1 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
2 California, as follows:

3 Section 1: On April 24, 2018, the City Council held a public hearing on the proposed
4 Freeway Agreement in accordance with California Streets and Highways Code section 100.22.

5 Section 2: The Freeway Agreement concerning that portion of State Highway 91 from
6 Buchanan Street to Route 60/91/215 Interchange is hereby approved.

7 Section 3: The Mayor is hereby authorized to execute the Freeway Agreement between the
8 City of Riverside and the State of California acting by an through the Department of Transportation
9 for that portion State Highway 91 from Buchanan Street to Route 60/91/215 Interchange.
