A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, APPROVING A FREEWAY AGREEMENT WITH THE STATE OF CALIFORNIA DEPARTMENT OF TRANSPORTATION AND AUTHORIZING THE MAYOR TO EXECUTE THE AGREEMENT

WHEREAS, State Highway 91 from Buchanan Street to Route 60/91/215 Interchange has been declared to be a freeway by Resolutions of the California Transportations Commission on January 20, 1954 and June 20, 1956; and

WHEREAS, the State of California Department of Transportation ("Caltrans") and the County of Riverside ("County") have entered into a Supplemental Freeway Agreement dated December 23, 1957, relating to that portion of State Highway Route 91 (old Route 43) from east of East Grand Boulevard to one quarter mile west of Tyler Street; and

WHEREAS, the City subsequently incorporated and included certain areas from the County, including portions of such freeway from Buchanan Street to one quarter mile west of Tyler Street; and

WHEREAS, Caltrans and the City entered into a Supplemental Freeway Agreement dated January 15, 1957, relating to that portion of State Highway Route 91 (old Route 43) from one quarter mile west of Tyler Street to Adams Street; and

WHEREAS, Caltrans and the City entered into a Freeway Agreement dated July 13, 2010, relating to that portion of State Highway Route 91 from Adams Street to Route 60/91/215 Interchange; and

WHEREAS, a revised plan map for such freeway has been prepared showing the proposed plan of Caltrans as it affects roads of the City; and

WHEREAS, it is the mutual desire of the parties hereto to enter into a new Freeway Agreement in accordance with the revised plan of said freeway; and

WHEREAS, the City has complied with the provisions of California Streets and Highways Code section 100.22 by holding a public hearing on April 24, 2018.

6	Buchanan Street to Route 60/91/215 Interchange is hereby approved.				
7	Section 3: The Mayor is hereby authorized to execute the Freeway Agreement between the				
8	City of Riverside and the State of California acting by an through the Department of Transportation				
9	for that portion State Highway 91 from Buchanan Street to Route 60/91/215 Interchange.
