PURCHASE AND INSTALLATION OF SIX UMBRELLAS FOR SUCCESSOR AGENCY-OWNED CALIFORNIA TOWER COMMERCIAL BUILDING - 3737 MAIN STREET - RESOLUTION

The Oversight Board (1) adopted a resolution authorizing the purchase and installation of six umbrellas for the Successor Agency-owned California Tower commercial building located at 3737 Main Street, in an amount not-to-exceed \$86,709; and (2) authorized Inland Pacific Advisors to retain USA Shade and Fabric firm at a cost not-to-exceed \$82,580 for the installation of the new umbrellas and approve a project management payment of up to \$4,129 by the Successor Agency to pay Inland Pacific Advisors to oversee the installation of the umbrellas; whereupon, the title having been read and further reading waived, Resolution No. 103 of the Oversight Board for City of Riverside as Successor Agency to the Redevelopment Agency of the City of Riverside Authorizing the Purchase and Installation of Six (6) New Umbrellas for the California Tower Commercial Building Located at 3737 Main Street, was presented and adopted.
