1 ORDINANCE NO. 2 AN ORDINANCE OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING SECTION 10.56.050 OF THE RIVERSIDE MUNICIPAL CODE TO 3 ESTABLISH AXLE RESTRICTIONS ON SEGMENTS OF ALESSANDRO BOULEVARD, ARLINGTON, CENTRAL, CHICAGO, IOWA, AND JURUPA 4 AVENUES. 5 6 The City Council of the City of Riverside does ordain as follows: 7 Section 1: Section 10.56.050 of the Riverside Municipal Code is hereby amended to read 8 as follows: 9 Section 10.56.050 Commercial vehicles exceeding three (3) axles prohibited from using certain streets. 10 11 When signs are erected giving notice thereof, no person shall operate any commercial vehicle exceeding three (3) axles at any time upon any of the streets or parts of streets 12 listed below, except that such vehicle may be operated thereon for the purpose of delivering or picking up materials or merchandise or the performance of services in 13 connection with and in aid of a property in the block, and then only by entering such 14 street at the intersection nearest the destination of the vehicle and proceeding thereon no farther than the nearest intersection thereafter: 15 Exceeding Three (3) Axles: 16 Name of Street Limits of Prohibition 17 Alessandro Boulevard Central Avenue to Trautwein Road 18 Arlington Avenue Horace Street to Chicago Avenue 19 20 Central Avenue Fremont Street to Brockton Avenue 2.1 Central Avenue Alessandro Boulevard to State Route 91 22 23 Chicago Avenue Arlington Avenue to Central Avenue 2.4 Iowa Avenue Spruce Street to Blaine Street 25 Fremont Street to Brockton Avenue Jurupa Avenue 26 27 Main Street Columbia Avenue and the SR-60 Freeway 28
