

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,  
3 CALIFORNIA, AMENDING RESOLUTION NO. 22451 KNOWN AS THE  
4 MASTER PARKING SCHEDULE RESOLUTION TO ESTABLISH A NO  
5 PARKING ZONE ON SYCAMORE CANYON BOULEVARD.

6 WHEREAS, the Public Works Department received a request to prohibit parking along  
7 Sycamore Canyon Boulevard from El Cerrito Drive to Central Avenue to address concerns  
8 regarding 72-hour parking violations, commercial truck parking outside of the designated parking  
9 areas, and illegal dumping occurring in the area; and

10 WHEREAS, as there are no improved properties that front the above stretch of roadway,  
11 the Public Works Department supports the establishment of a No Parking Any Time restriction  
12 within the segment to deter illegal parking and activity as well as illegal dumping along this  
13 stretch of roadway; and

14 WHEREAS, on April 4, 2018, the Transportation Board unanimously recommended the  
15 proposal to establish a No Parking zone on both sides of Sycamore Canyon Boulevard from El  
16 Cerrito Drive to Central Avenue.

17 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,  
18 California, as follows:

19 Section 1: The recitals set forth above are incorporated herein by reference.

20 Section 2: That the Master Parking Schedule is hereby amended by establishing a “No  
21 Parking Any Time” zone on both sides of Sycamore Canyon Boulevard from El Cerrito Drive to  
22 Central Avenue.

23 Section 3: That the provisions of this resolution shall be operative only when signs are  
24 erected on that portion of the street set forth in Section 2 above, giving notice of the parking  
25 limitations or prohibitions herein established.

26 Section 4: The provisions of this amendment shall be operative as of the date of adoption  
27 of this resolution.
