4	PARKING ZONE ON SYCAMORE CANYON BOULEVARD.
5	WHEREAS, the Public Works Department received a request to prohibit parking along
6	Sycamore Canyon Boulevard from El Cerrito Drive to Central Avenue to address concerns
7	regarding 72-hour parking violations, commercial truck parking outside of the designated parking
8	areas, and illegal dumping occurring in the area; and
9	WHEREAS, as there are no improved properties that front the above stretch of roadway,
10	the Public Works Department supports the establishment of a No Parking Any Time restriction
11	within the segment to deter illegal parking and activity as well as illegal dumping along this
12	stretch of roadway; and
13	WHEREAS, on April 4, 2018, the Transportation Board unanimously recommended the
14	proposal to establish a No Parking zone on both sides of Sycamore Canyon Boulevard from El
15	Cerrito Drive to Central Avenue.
16	NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
17	California, as follows:
18	Section 1: The recitals set forth above are incorporated herein by reference.
19	Section 2: That the Master Parking Schedule is hereby amended by establishing a "No
20	Parking Any Time" zone on both sides of Sycamore Canyon Boulevard from El Cerrito Drive to
21	Central Avenue.
22	Section 3: That the provisions of this resolution shall be operative only when signs are
23	erected on that portion of the street set forth in Section 2 above, giving notice of the parking
24	limitations or prohibitions herein established.
25	Section 4: The provisions of this amendment shall be operative as of the date of adoption
26	of this resolution.
