1 RESOLUTION NO. 2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING RESOLUTION NO. 22451 KNOWN AS THE 3 MASTER PARKING SCHEDULE RESOLUTION TO ESTABLISH A 1-HOUR PARKING ZONE ON CENTER STREET. 4 WHEREAS, the Public Works Department received a request from the group performing 5 rehabilitation of the historic Trujillo Adobe located on the north side of Center Street west of 6 Orange Street; and WHEREAS, on December 8, 2015, the City Council designated the adobe site as a local 8 City Landmark due to its historic significance and the adobe continues to attract visitors and 9 historians alike; and 10 WHEREAS, the rehabilitation group indicated that trucks are often parked at the front of 11 the Trujillo Adobe property and gate during typical visitor hours, preventing visitor parking 12 and/or impacting the ability to photograph the site; and 13 WHEREAS, the rehabilitation group has requested that a 1-Hour Parking zone be 14 established to allow for short-term parking and turn-over of parking spaces at the front of the 15 property; and 16 WHEREAS, the establishment of the 1-Hour Parking zone will provide convenient visitor 17 access to and view of the landmark site and allow for longer term parking during later evening 18 and early morning hours; and 19 WHEREAS, on April 4, 2018, the Transportation Board unanimously recommended the 20 proposal to establish a 1-Hour Parking zone on the north side of Center Street west of Orange 2.1 Street at the frontage of the Trujillo Adobe. 22 23 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, 2.4 California, as follows: 25 <u>Section 1</u>: The recitals set forth above are incorporated herein by reference. Section 2: That the Master Parking Schedule is hereby amended by establishing a "1-26 Hour Parking between the hours of 8:00 a.m. to 6:00 p.m. Daily" Zone on the north side of Center 27

Street from 125 feet west of Orange Street to 220 feet westerly thereof.

1	Section 3: That the provisions of this resolution shall be operative only when signs are
2	erected on that portion of the street set forth in Section 2 above, giving notice of the parking
3	limitations or prohibitions herein established.
4	Section 4: The provisions of this amendment shall be operative as of the date of adoption
5	of this resolution.
