2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
3 RIVERSIDE, CALIFORNIA, AMENDING RESOLUTION NO.  
4 21052 TO AMEND THE MASTER FRINGE BENEFITS AND  
5 SALARY PLAN TO CHANGE THE EXECUTIVE  
6 MANAGEMENT BENEFITS.

7 WHEREAS, on October 4, 2005, Resolution No. 21052 was adopted by the City Council  
8 thereby adopting the Master Fringe Benefits and Salary Plan ("FBSP"); and

9 WHEREAS, the FBSP includes the fringe benefits and salary plans for City employees;  
10 and

11 WHEREAS, the FBSP has been amended several times to update the benefits and  
12 salaries; and

13 WHEREAS, changes to the FBSP need to be made to correspond to the current charter  
14 officer contracts.

15 NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, as  
16 follows:

17 Section 1: Resolution No. 21052, the Master Fringe Benefits and Salary Plan, is  
18 hereby amended as set forth in Exhibit "A" attached hereto and incorporated herein by reference.

19 Section 2: Authorize the City Manager, or his designee, to make minor, non-  
20 substantive changes to the Master Fringe Benefits and Salary Plan and any related policies,  
21 procedures or documents necessary to implement these provisions.

22 Section 3: The provisions of this resolution shall be operative upon adoption.
