

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
3 RIVERSIDE, CALIFORNIA, AMENDING THE CITY'S FEES AND
4 CHARGES SCHEDULE IN RESOLUTION NO. 21960, AS AMENDED,
5 PROVIDING FOR A COMPREHENSIVE SCHEDULE OF ALL CURRENT
6 FEES AND CHARGES.

7 WHEREAS, the City has the authority to impose fees under its police power under Article
8 XI, §7 of the California Constitution and under its complementary powers under Section 37112 of
9 the California Government Code and Section 200 of the Riverside City Charter; and

10 WHEREAS, the City has established a policy of recovering the full costs reasonably borne as
11 a result of providing special services of a voluntary and limited nature, such that general taxes are
12 not diverted from general services of a broad nature and thereby utilized to subsidize unfairly and
13 inequitably such special services; and

14 WHEREAS, in Chapter 3.30 of the Riverside Municipal Code, the City Council established
15 its policy as to the recovery of costs and more particularly the percentage of costs reasonably borne
16 to be recovered from users of City services and directing staff as to the methodology for
17 implementing said Chapter 3.30; and

18 WHEREAS, the specific fees to be charged for services are to be reviewed annually and be
19 adopted by resolution of the City Council, were made available to the public at least ten (10) days
20 prior to the City Council meeting of June 12, 2018; and

21 WHEREAS, the City adopted its Master Fees and Charges Resolution, Resolution No.
22 21960, on January 12, 2010, which resolution has been amended several times; and

23 WHEREAS, the City desires to adopt the new Masters Fees and Charges Schedule as set
24 forth in Exhibit "A" attached hereto and incorporated herein, amending Resolution No. 21960 and
25 all its amendments.

26 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
27 California, as follows:

28 Section 1: The above recitals are hereby found to be true and correct and are hereby
incorporated herein as if stated in full.

1 Section 2: The City hereby adopts the new Masters Fees and Charges Schedule attached
2 herein as Exhibit “A” and incorporated herein by reference

3 Section 3: This Resolution, together with any other resolution amending Resolution No.
4 21960 and the Master Fees and Charges Schedule, shall collectively be known as, and hereinafter
5 may be interchangeably referred to as, the “Fees and Charges Resolution” or the “Master Fees and
6 Charges Schedule.”

7 Section 4: Resolution No. 21960 and all amendments not otherwise amended herein shall
8 remain in effect.

9 Section 5: The provisions of this Resolution shall become effective immediately upon
10 adoption.
