### Legislative Background

#### 1. Assembly Bill (AB) 1890

Requires 2.85% of electric revenue to be utilized for:

- a. demand-side management (energy efficiency)
- b. renewable energy
- c. low-income assistance
- d. research, development & demonstration

### 2. Senate Bill (SB) 1037

"first acquire all available energy efficiency and demand reduction resources that are cost-effective, reliable, and feasible"

## Legislative Background

- **3. AB 2021** requires POUs to:
  - a. identify all potentially achievable cost-effective electricity efficiency savings
  - b. establish annual targets for energy efficiency savings and demand reduction over ten years
  - c. City Council set RPU's target at 1% of annual retail energy sales
- 4. SB 350 requires statewide:
  - a. energy efficiency savings and demand reduction
  - b. cumulative doubling of energy efficiency by January 1, 2030

#### **Council Direction**

- 1. August 14, 2007 City Council unanimously approved the use of SCPPA for the procurement of energy efficiency and conservation programs and services.
- 2. February 21, 2017 City Council directed staff to:
  - a. Provide detailed proposed SCPPA expenditures to Board and to City Council.
  - b. Deliver a bi-annual report to the Board and City Council on expenditures.
  - c. Seek City Council approval of task orders over \$50,000.

## What is Southern California Public Power Authority (SCPPA)

Joint powers agency comprised of eleven municipal utilities and one irrigation district

- 1. Formed in 1980, provides joint financing, construction, and operation of transmission and generation projects
- 2. SCPPA members enjoy economies of scale pricing

## RPU Procurement Process through SCPPA Energy Efficiency Programs

- 1. SCPPA posts a competitive Request for Proposal (RFP)
- 2. SCPPA enters into a Master Professional Services Agreement (MPSA) with awarded contractor(s)
- 3. Member agencies participate in these energy efficiency programs through a Task Order
  - a. A Task Order is a detailed program agreement between a member agency and the selected contractor





### **Customer Benefit**

- SCPPA Contracts include economiesof-scale pricing
  - a. <u>4%-33%</u> discount depending on the specific program
- 2. RPU realizes nearly 16% or \$500,000 per year in savings
- 3. All SCPPA RFPs are evaluated by subject matter experts from SCPPA member agencies

## **Program Outreach**

### 1. Vendor-Driven Outreach to Supplement RPU Staff

Allows RPU to contact more customers and increase program participation

### 2. Customer Inquiry

- a. Any RPU customer may contact 311 or Customer Service and request program information from an RPU Program Manager
- b. Program Manager will advise and enroll customer into any program that will benefit the customer

### New - Business Outdoor Lighting Direct Installation Richard Heath & Associates (RHA)

- The Task Order between RPU and RHA is for Fiscal Year 2018-19 in the amount of \$965,000
- This program is expected to achieve an estimated energy savings target of 2,350 MWh
- 3. SCPPA Discount = 20%
- Vendor makes direct contact with those customers who qualify based on their load and existing lighting

# Upstream High Efficiency HVAC Program Energy Solutions

- 1. The Task Order between RPU and Energy Solutions is for Fiscal Year 2018-19 in the amount of \$250,000
- This program is expected to achieve an estimated energy savings target of 840 MWh
- 3. SCPPA Discount = 12.5%
- 4. Vendor outreach to all HVAC distributors in RPU service territory

### Multifamily & Mobile Home Direct Installation Program Synergy Companies

- 1. The Task Order between RPU and Synergy Companies is for Fiscal Year 2018-19 in the amount of **\$150,000**
- This program is expected to achieve an estimated energy savings target of 1,200 MWh
- 3. SCPPA Discount = 12%
- 4. Vendor outreach to all multifamily and mobile home parks in RPU service territory

## LED Buydown Program *GreenLite*

- The Task Order between RPU and GreenLite Lighting Corp USA is for Fiscal Year 2018-19 in the amount of \$300,000
- This program is expected to achieve an estimated energy savings target of 1,800 MWh
- 3. SCPPA Discount = 4%
- 4. RPU general promotion bills, website, advertisements, point of purchase, etc.

## Small Business Direct Installation Program *Lime Energy*

- 1. Task Order between RPU and Lime Energy is for Fiscal Year 2018-19 in the amount of \$965,000
- This program is expected to achieve an estimated energy savings target of 2,500 MWh
- 3. SCPPA Discount = 20%
- 4. Vendor makes contact with those customers who qualify based on electric consumption

# The Keep Your Cool Program Efficiency Services Group

- The Task Order between RPU and Efficiency Services Group is for Fiscal Year 2018-19 in the amount of \$100,000
- This program is expected to achieve an estimated energy savings target of 375 MWh
- 3. SCPPA Discount = 25%
- 4. Vendor makes contact with customers with significant refrigeration usage

# Key Account Energy Efficiency Program Muni-Fed Partner Energy

- 1. The Task Order between RPU and Muni-Fed Partner Energy is for Fiscal Year 2018-19 in the amount of **\$150,000**
- This program seeks to achieve an estimated energy savings target of 1,500 MWh
- 3. SCPPA Discount = 33%
- 4. Vendor contacts customers based on usage and at RPU's request

## Customer Engagement Program Oracle/Opower

- 1. The Task Order between RPU and Oracle America Inc. is for Fiscal Year 2018-19 in the amount of \$275,000
- This program seeks to achieve an estimated energy savings target of 2,720 MWh



- 3. SCPPA Discount = 5%
- 4. 24,000 residential customers randomly selected
