

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,  
3 CALIFORNIA, AMENDING THE HOUSING ELEMENT OF THE  
4 GENERAL PLAN 2025 TO ADOPT A MID-CYCLE UPDATE TO THE 5<sup>TH</sup>  
5 CYCLE 2014-2021 HOUSING ELEMENT.

6 WHEREAS, on October 10, 2017, the City of Riverside adopted the 2014-2021 Housing  
7 Element ("Project"); and

8 WHEREAS, on May 3, 2018, the Planning Commission of the City of Riverside held a public  
9 hearing to recommend the approval of an amendment to the Housing Element of the General Plan  
10 2025, to adopt a Mid-Cycle update to the 5<sup>th</sup> Cycle 2014-2021 Housing Element, pursuant to State  
11 Housing Element Law; and

12 WHEREAS, the City Council of the City of Riverside advertised for and held a public hearing  
13 on June 19, 2018, to consider the Project and recommend that Planning Case No. P18-0074 (General  
14 Plan Amendment) is exempt from the California Environmental Quality Act (CEQA) Section  
15 15061(b)(3) as it can be seen with certainty that there is no possibility that this proposal will have a  
16 significant impact on the environment; and

17 WHEREAS, the City Council received and considered the reports and recommendation from  
18 the Planning Commission and all other testimony, whether written or oral, presented at the public  
19 hearing.

20 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,  
21 California, as follows:

22 Section 1: It is in the public interest to amend the Housing Element of the General Plan  
23 2025, to adopt a Mid-Cycle update to the 5<sup>th</sup> Cycle 2014-2021 Housing Element.

24 Section 2: It is the independent judgment of the City Council of the City of Riverside that  
25 this amendment to the Housing Element of General Plan 2025 will not have a significant effect on the  
26 environment and is exempt from the CEQA review pursuant to Section 15061(b)(3).

27 Section 3: The Housing Element of the General Plan 2025 is hereby amended to adopt the  
28 Mid-Cycle Housing Element revisions as summarized in Exhibit "A" attached hereto and incorporated  
herein by reference.
