SUBJECT: AWARD BID NO. 7541 FOR THE CONSTRUCTION OF THE 2017/2018 RTA BUS

PAD IMPROVEMENTS TO EBS GENERAL ENGINEERING, INC., CORONA,

CALIFONRIA, IN THE AMOUNT OF \$987,900

<u>ISSUE</u>:

Award a construction contract for Bid No. 7541 for the 2017/2018 RTA Bus Pad Improvements at various locations throughout the City to EBS General Engineering, Inc., of Corona, California, in the amount of \$987,900.

RECOMMENDATIONS:

That the City Council:

- Award a construction contract for Bid No. 7541 for the 2017/2018 RTA Bus Pad Improvements to EBS General Engineering, Inc., of Corona, California, in the amount of \$987,900; and
- 2. Authorize the City Manager, or his designee, to execute the construction contract with EBS General Engineering, Inc., including making minor non-substantial changes.

BACKGROUND:

On November 14, 2017, the City Council approved a cooperative agreement with the Riverside Transit Agency (RTA) for the construction of new concrete bus pads for the RapidLink and Downtown bus stop locations; and authorized a supplement appropriation in the amount of \$969,362.

DISCUSSION:

The 2017/2018 RTA Bus Pads Improvements project (Project) will construct new steel-reinforced concrete bus pads in the Downtown area and along the Magnolia Avenue, Market Street, and University Avenue (Attachment 1). In order to minimize traffic delays, construction activity will be limited to 7 p.m. on Friday through 5 a.m. the following Monday. A rapid cure concrete mix will be utilized allowing the new bus pads to become fully operational within 60 hours after the concrete has been poured.

On May 1, 2018, three bids were received for the construction of the Project (Attachment 2). The

lowest responsive bid was from EBS General Engineering, Inc., in the amount of \$987,900, which is 2.5% under the Engineer's Estimate.

The Purchasing Manager concurs that the recommendation to award is in compliance with Purchasing Resolution 23256.

FISCAL IMPACT:

The estimated total Project cost including design, construction, construction engineering, and contingencies is \$1,180,000. There are sufficient funds available in accounts 9900600-440309 (RTA Bus Pad Construction) and 9888030-440313 (Major Streets Rehab – 2009 Measure A) to award the contract and complete the Project.
