THIS FIRST AMENDMENT TO AGREEMENT FOR THE MANAGEMENT AND OPERATION OF THE JANET GOESKE SENIOR CENTER ("First Amendment") is made and entered into this ____ day of _____, 2018, by and between the CITY OF RIVERSIDE, a California charter city and municipal corporation ("City"), and the JANET GOESKE FOUNDATION, a California corporation ("Contractor").

RECITALS

WHEREAS, on or about August 9, 2016, City and Contractor entered into an Agreement for the Management and Operation of the Janet Goeske Senior Center ("Agreement"); and

WHEREAS, the Agreement will expire on June 30, 2018; and

WHEREAS, City is satisfied with the performance of Contractor; and

WHEREAS, City and Contractor desire to extend the term of the Agreement by two years, to June 30, 2020.

NOW, THEREFORE, in consideration of the foregoing recitals which are incorporated herein by this reference, City and Contractor agree as follows:

1. Paragraph 2 of the Agreement ("Term") is hereby amended to read as follows:

"2. Term. This Agreement shall be effective on the date first written above and shall remain in effect until June 30, 2020, unless otherwise terminated pursuant to the provisions herein. This Agreement may be extended for one (1) two-year renewal upon the mutual agreement of both parties."


