BACKGROUND

- 1. Techite pipe is a vulnerability of RPU's water system.
- 2. RPU has begun replacing Techite pipe.
- 3. Public Works Department street improvement project along Magnolia Avenue between Buchanan Street and Hole Avenue.

BACKGROUND (CONT.)

- 4. Opportunity to replace Techite pipe and realize cost savings.
- 5. A budgetary amount of \$484,000 was approved on January 8, 2018 for upfront design costs.
- 6. A Supplemental Appropriation of \$5,216,000 was approved by the City Council on March 13, 2018.

- 7. Coordination with Public Works.
- 8. Coordination with Energy Delivery Division.
- 9. Major business district; Nighttime construction at select locations.





- 10. Initially advertised the project in March 2018.
- 11. Bids received were high; Rejected all bids and retooled the scope of work.
- 12. Re-advertised the project in April 2018.

BID RESULTS

- 1. The project was originally advertised on March 22, 2018.
- 2. Bids were higher than expected; exceeded the budget.
 - a) Tariff on imported steel and aluminum
 - b) Higher than expected material and labor costs
- 3. Purchasing Manager rejected all bids on April 10, 2018
 - a) Allow staff to retool the scope of work and re-advertise to achieve cost savings
- 4. Re-advertised on April 20, 2018.

- 1. RFP for Geotechnical and Materials Testing Services was issued on May 8, 2018.
- 2. Thirteen proposals received.
- 3. SCST, Inc. of Riverside, California was selected.
- 4. Professional Consultant Services Agreement negotiated for \$101,628.

RECOMMENDATIONS

That the Board of Public Utilities:

- 1. Award Bid No. RPU-7569 to Weka, Inc., of Highland, California, in the amount of \$5,939,308;
- 2. Authorize additional change order authority for the Weka, Inc. Construction Contract in the amount of 10% or \$593,930 for Bid No. RPU-7569;
- 3. Approve a Professional Consultant Services Agreement from RFP 1826 with SCST, Inc. of Riverside, California, for Geotechnical and Materials Testing Services for the Magnolia Avenue Techite Pipe and Pressure Reducing Station Replacement Project, term through June 30, 2019, in a not-to-exceed amount of \$101,628;
- 4. Authorize the City Manager, or his designee, to execute the Professional Consultant Services Agreement with SCST, Inc., including making minor and non-substantive changes;



RECOMMENDATIONS (CONT.)

- 5. Approve the increased capital expenditure for Work Order No. 1612632 for the Pipeline Replacements in the amount of \$6,851,000 for a revised work order total of \$7,335,000 which includes all design, utility potholing, construction, paving, contract administration, inspection and construction change order authority costs for the Magnolia Avenue Techite Pipe and Pressure Reducing Station Replacement Project;
- 6. Approve the capital expenditure for Work Order No. 1727999 for the Pressure Reducing Station Replacement in the amount of \$599,000 which includes all design, utility potholing, property acquisition, construction, paving, contract administration, inspection and construction change order authority costs for the Magnolia Avenue Techite Pipe and Pressure Reducing Station Replacement Project; and
- 7. Authorize the City Manager, or his designee, to increase or decrease the abovenoted work order amounts, in collective amounts not-to-exceed the total project cost of \$7,934,000.
