**SUBJECT: PURCHASE OF FIFTY PANASONIC CF-33 TOUGHBOOKS AND ACCESSORIES FROM STOMMEL, INC. OF ANAHEIM, CALIFORNIA, IN THE AMOUNT OF \$251,245**

## **ISSUE:**

Approve the purchase of fifty Panasonic CF-33 Toughbooks and accessories in the amount of \$251,245, from Stommel, Inc., of Anaheim, California.

## **RECOMMENDATION:**

That the City Council approve the purchase of fifty (50) Panasonic CF-33 Toughbooks and accessories in the amount of \$251,245, from Stommel, Inc. of Anaheim, California, in accordance with Purchasing Resolution No. 23256, Section 602(g).

## **BACKGROUND:**

On July 14, 2015, City Council approved the Police Department's request to acquire equipment to join the Riverside County Public Safety Enterprise Communication System (PSEC) for an estimated cost of up to \$7 million. The costs of the PSEC system were financed with a capital lease in the amount of \$7 million.

Subsequently, the costs of the system were below the \$7 million initially authorized by Council and on March 1, 2016, the Council approved the use of funds remaining in the PSEC project to be repurposed toward the new Records Management System (RMS).

On October 25, 2016, City Council approved the award of the RMS for \$1,304,070.

## **DISCUSSION:**

In order to implement the new RMS, the Police Department will need to purchase new computer equipment for the patrol cars. The existing Panasonic CF-30 and CF-31 Toughbook computers do not have enough storage space or processor speed to work with the new systems.

On April 17, 2018, the City Council awarded Bid No. 7550 for the purchase of twenty-five (25) Panasonic CF-33 Toughbooks and accessories to Stommel, Inc. of Anaheim, California. The Police Department would now like to purchase an additional fifty (50) Panasonic CF-33

Toughbooks and accessories.

Stommel, Inc. has agreed to provide the Panasonic CF-33 Toughbooks and accessories at the same amount awarded in Bid No. 7550, in the amount of \$5,024.90 each.

Purchasing Resolution No. 23256, Section 602(g) that allows for procuring from a Bidder who offers the same or better price, terms and conditions as the Bidder previously offered as the Lowest Responsive Bidder under Competitive Procurement provided that, in the opinion of the Manager, it is in the best interests of the City to do so. The Purchasing Manager made the determination that the procurement is in the best interest of the City and concurs that the recommended action is in compliance with resolution.

The Interim Chief Innovation Officer concurs with the recommendations of this report.

**FISCAL IMPACT:**

The total fiscal impact of the action is \$251,245. Sufficient funds are available in the PD – Lease – PSEC/RMS Account No. 9890700203-46230000.
