2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
3 RIVERSIDE, CALIFORNIA, ACCEPTING THE DEPARTMENT OF
4 ALCOHOLIC BEVERAGE CONTROL'S 2018/2019 GRANT AWARD TO
5 INCREASE ENFORCEMENT ACTIVITY IN RELATION TO
ALCOHOLIC BEVERAGE CONTROL (ABC) VIOLATIONS; AND
AUTHORIZING THE EXECUTION OF THE NECESSARY DOCUMENTS
BY THE CITY MANAGER OR HIS DESIGNEE.

6 WHEREAS, the Riverside Police Department has applied for and received a grant award for
7 Fifty-Four Thousand Two Hundred Forty-Seven Dollars (\$54,247.00) to increase enforcement
8 activity in relation to Alcoholic Beverage Control (ABC) violations; and

9 WHEREAS, certain funds are available through the Department of Alcoholic Beverage
10 Control to increase enforcement activity and to expand the Police Department's expertise in
11 managing ABC-related problems; and

12 WHEREAS, the grant will also help incorporate ABC-related issues into Community
13 Policing by educating and involving the community and media in resolving alcohol-related problems
14 and issues; and

15 WHEREAS, City of Riverside agrees to assume responsibility for any liability arising out of
16 the performance of this grant award and contract, including civil court actions for damages. The
17 State of California and ABC disclaim responsibility for any such liability;

18 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
19 California, as follows:

20 Section 1: That the grant award in the amount of Fifty-Four Thousand Two Hundred Forty-
21 Seven Dollars (\$54,247.00) from the Department of Alcoholic Beverage Control Grant Assistance to
22 Local Law Enforcement Agencies Project is hereby accepted and the City Manager of the City of
23 Riverside or his designee is hereby authorized and directed to execute the necessary documents in
24 connection therewith, including the grant award contracts or any extensions or amendments thereof.

25 Section 2: That any liability arising out of the performance of this grant award and contract,
26 including civil court actions for damages, shall be the responsibility of the City of Riverside. The
27 State of California and ABC disclaim responsibility for any such liability.

Section 3: That any and all grant funds received hereunder shall not be used to supplant expenditures controlled by the City of Riverside.

Section 4: That this grant award is not subject to local hiring freezes.
