A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, ACCEPTING THE DEPARTMENT OF ALCOHOLIC BEVERAGE CONTROL'S 2018/2019 GRANT AWARD TO ACTIVITY IN INCREASE ENFORCEMENT RELATION TO BEVERAGE CONTROL (ABC) VIOLATIONS: ALCOHOLIC AND AUTHORIZING THE EXECUTION OF THE NECESSARY DOCUMENTS BY THE CITY MANAGER OR HIS DESIGNEE.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, as follows:

Section 1: That the grant award in the amount of Fifty-Four Thousand Two Hundred Forty-Seven Dollars (\$54,247.00) from the Department of Alcoholic Beverage Control Grant Assistance to Local Law Enforcement Agencies Project is hereby accepted and the City Manager of the City of Riverside or his designee is hereby authorized and directed to execute the necessary documents in connection therewith, including the grant award contracts or any extensions or amendments thereof.

<u>Section 2</u>: That any liability arising out of the performance of this grant award and contract,
including civil court actions for damages, shall be the responsibility of the City of Riverside. The
State of California and ABC disclaim responsibility for any such liability.
