11	salaries; and
12	WHEREAS, the Job Code Table of the FBSP needs to be revised to reflect the creation of
13	classification and salary ranges that have been proposed for the Performance Analyst, Senior
14	Performance Analyst, and Organizational Performance and Audit Manager positions.
15	NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, as
16	follows:
17	<u>Section 1:</u> Resolution No. 21052 and the Master Fringe Benefits and Salary Plan are
18	hereby amended to create the classification and salary ranges for the Performance Analyst,
19	Senior Performance Analyst, and Organizational Performance and Audit Manager positions as
20	set forth in Exhibit "A" attached hereto and incorporated herein by reference.
21	Section 2: Authorize the City Manager, or his designee, to make minor, non-
22	substantive changes to the Master Fringe Benefits and Salary Plan and any related policies,
23	procedures or documents necessary to implement these provisions.
24	<u>Section 3:</u> The provisions of this resolution shall be operative upon adoption.
