

1 RESOLUTION NO.

2 A RESOLUTION OF THE HOUSING AUTHORITY OF THE CITY OF
3 RIVERSIDE, CALIFORNIA, AUTHORIZING THE SUBMISSION OF AN
4 APPLICATION TO THE NATIONAL HOUSING TRUST FUND PROGRAM
5 ADMINISTERED THROUGH THE CALIFORNIA DEPARTMENT OF
6 HOUSING AND COMMUNITY DEVELOPMENT AND AUTHORIZING THE
7 EXECUTION OF ALL REQUIRED DOCUMENTS BY THE EXECUTIVE
8 DIRECTOR OR HIS DESIGNEE.

9 WHEREAS, the United States Department of Housing and Urban Development
10 (“Grantor”), through the State of California Department of Housing and Community
11 Development, has heretofore invited public agencies, including the Housing Authority of the
12 City of Riverside (“Authority”), to submit applications to the Grantor for the Fiscal Year 2018
13 National Housing Trust Fund Program (“Grant”) via a Notice of Funding Availability dated June
14 5, 2018; and

15 WHEREAS, in response to this Notice of Funding Availability, the Authority wishes to
16 apply to the Grantor for, and receive an allocation of, funds from the Grant (“Grant Funds”); and

17 WHEREAS, the Authority has determined that it is in its best interests to submit an
18 application for Grant Funds for the Mulberry Village Permanent Supportive Housing Project, a
19 ten-unit transitional housing project (“Project”); and

20 WHEREAS, the Authority shall submit an application to the Grantor to participate in the
21 Grant program and for an allocation of funds not to exceed Seven Hundred Fifteen Thousand
22 Dollars (\$715,000) for the Project; and

23 WHEREAS, the Authority is familiar with the terms, conditions and limitations of the
24 Grant; and

25 WHEREAS, the Authority is willing and able to conform to each of the terms, conditions
26 and limitations imposed upon such Grant to the Authority; and

27 WHEREAS, the Grantor must approve said application and will require the Authority to
28 execute a Funding Agreement and other necessary documents upon approval.

NOW, THEREFORE, BE IT RESOLVED by the Board of the Housing Authority of the
City of Riverside, California, as follows:

1 Section 1. In response to this Notice of Funding Availability, the Executive Director, or
2 his designee, is authorized to submit an application to the Grantor to participate in the Grant
3 Program and for an allocation of funds not to exceed Seven Hundred Fifteen Thousand Dollars
4 (\$715,000) for the ten-unit transitional housing project known as Mulberry Village Permanent
5 Supportive Housing Project, located in Riverside, California.

6 Section 2. Upon approval of the Grant, then the Authority hereby agrees to use the Grant
7 Funds for eligible activities in the manner presented in its application as approved by the Grantor
8 in accordance with the statutes and regulations cited above.

9 Section 3. That the Executive Director or his designee is hereby authorized to execute
10 any and all applications for Grant Funds and other necessary documents for the purpose of
11 obtaining federal financial assistance provided by the United States Department of Housing and
12 Urban Development and sub-granted through the State of California Department of Housing and
13 Community Development, including any extensions, amendments or documents required by
14 Grantor.

15 Section 4. The Housing Authority of the City of Riverside hereby agrees to comply with
16 each and all of the terms, conditions and limitations imposed by the Grantor upon said Grant, and
17 the Executive Director or his designee is hereby authorized and directed to execute any
18 applications, agreements, assurance or other documents as may be necessary in connection with
19 acceptance and implementation of said Grant as may be required by the Grantor.
