RECITALS

WHEREAS, the City and Consultant entered into that certain Professional Consultant Services Agreement dated February 14, 2018 ("Agreement") for Facilities Assessment and Work Order Management Software Pilot Program; and

WHEREAS, the City has been satisfied with Consultant's performance under the Agreement and desires to have Consultant continue providing the services referenced in that Agreement; and

WHEREAS, the City and Consultant have agreed to extend the term of the Agreement by one (1) additional year From June 30, 2018 through June 30, 2019, and increase compensation by One Hundred Fifty-Nine Thousand, Four Hundred Seventy Dollars (\$159,470.00).

NOW, THEREFORE, incorporating the recitals set out above, the parties hereto mutually agree to the following amendment to the Agreement.

- 1. Section 2, Term, is hereby amended to extend the term of the Agreement by one (1) additional year through June 30, 2019.
- 2. Section 3, Compensation/Payment, is amended to increase the compensation by One Hundred Fifty-Nine Thousand, Four Hundred Seventy Dollars (\$159,470.00), for a contract total of Two Hundred Nine Thousand Fifty Five Dollars and Twenty Eight Cents (\$209,055.28).
- 3. All other terms and conditions of the Agreement between the parties, which are not inconsistent with the terms of this First Amendment, shall remain in full force and effect as if fully set forth herein.
