PARTICIPATING ADDENDUM UNDER THE NASPO VALUEPOINT WIRELESS COMMUNICATION SERVICES AND EQUIPMENT BID NUMBER RFP: #1907

SUB-PARTICIPATING ADDENDUM PARTICIPATING ENTITY: City of Riverside

This Sub-Participating Addendum (the "Sub-PA") is made this 20± day of September, 2018 (the "Sub-PA Effective Date"), between City of Riverside ("Participating Entity"), and AT&T Mobility National Accounts LLC ("Contractor") (Participating Entity and Contractor are, at times, referred to individually as a "Party" or together as the "Parties").

Section 1. Recitals.

- 1.1 Contractor and the State of Nevada, acting through its Department of Administration, Purchasing Division, and the participating members of the NASPO Cooperative Purchasing Program, d/b/a "NASPO ValuePoint" (formerly known as "WSCA" or "WSCA-NASPO") (hereinafter defined as "NASPO" or "WSCA"), are parties to that certain wireless communication services and equipment contract #1907, dated March 15, 2012, as amended (the "Contract" or "Master Service Agreement").
- 1.2 Pursuant to a Participating Addendum by and between Contractor and State of California, Master Price Contract #7-11-70-17, as amended on August 10, 2012, (the "PA"), Participating Entity is authorized to purchase Service, Equipment and related products from Contractor under the terms of the NASPO Contract and the PA.
- 1.3 As authorized by the Contract, and in addition to the standard Service, Equipment and related products available through the PA, Participating Entity wants to receive certain unique offers under the PA that will apply only to Participating Entity.
- **1.4** Contractor is willing to provide Participating Entity with such unique offers subject to the terms and conditions of the Sub-PA.
- Section 2. Agreement. In consideration of the recitals set forth in §1 above, which are hereby re-stated and agreed to by the Parties, and for valuable consideration, the receipt and sufficiency of which is hereby acknowledged by the Parties, Participating Entity and Contractor hereby agree to the terms and conditions of the Sub-PA (the Contract, the PA and the Sub-PA, together with all valid purchase orders submitted to Contractor by Participating Entity, collectively, the "Agreement"). Unless otherwise defined, capitalized terms in the Sub-PA have the meanings ascribed to them in the Contract and/or the PA.
- <u>Section 3.</u> <u>Authorized Participating Entity.</u> Participating Entity is the only authorized Participating Entity under the Sub-PA.
- Section 4. Purchase Orders. Participating Entity must issue purchase orders hereunder that reference both Master Service Agreement #1907 and the Sub-PA. Upon issuance of any such valid purchase order, Participating Entity will be bound by the terms and conditions of the Agreement including, without limitation, the obligation to pay Contractor for Service, Equipment, and related products provided. Notwithstanding the foregoing, any purchase order submitted that does not properly reference the Contract number and/or the Sub-PA may be accepted, at Contractor's sole discretion, if Contractor can reasonably ascertain that such purchase order was properly authorized and intended for use with the Sub-PA. In such instances, the corresponding purchase order will be similarly valid and binding. Except as expressly provided in the Agreement, terms and conditions inconsistent with, contrary or in addition to the terms and conditions of

the Agreement will not be added to or incorporated into the Agreement by any purchase order; and any such attempts to add or incorporate such terms and conditions are hereby rejected. The terms and conditions of the Agreement will prevail and govern in the case of any such inconsistent or additional terms.

Section 5. Custom Plans.

Provided Participant remains in full compliance with Custom FirstNet Mobile Plans - Agency Paid. the terms and conditions of the Agreement, and subject to all corresponding conditions set forth in this §5 (including all sub-sections and Tables), AT&T will provide Participant and its eligible CRUs the custom FirstNet Mobile Plans described in §5.1 (the "Custom FirstNet Mobile Plans"). The Custom FirstNet Mobile Plans are available for the term of the Agreement. The corresponding CRU must be eligible to activate Service on the underlying, non-customized version of the corresponding FirstNet Mobile Plan. The Custom FirstNet Mobile Plans are not available to IRUs or to individuals eligible to purchase the subscriber paid versions of FirstNet Mobile Plans. In accordance with the Agreement, the Custom FirstNet Mobile Plans are subject to the applicable, standard FirstNet Mobile-Pooled and Mobile-Unlimited Plans' corresponding Sales Information, which are incorporated herein by reference. To the extent of any material conflict between the terms and conditions of this §5.1 and the applicable Sales Information, this §5.1 will control. Notwithstanding the foregoing, the Custom FirstNet Mobile Plans will be provided only if Participant's account is active and in good standing with respect to the applicable CRU. The Custom FirstNet Mobile Plans are NOT eligible for the Service Discount, any other discount provided under the Agreement, nor any other discounts or promotions otherwise available to AT&T's customers. For all Custom FirstNet Mobile Plans, the corresponding Plan's Monthly Service Charge (at times, "MSC") will appear on the invoice at the standard price set forth in the Sales Information, but the customized net monthly price set forth in the corresponding table will be achieved via application of a modifier also reflected on the invoice.

Section 8. Authority. By signing below, the corresponding Party's representative represents that he or she is duly authorized by Contractor or Participating Entity, as applicable, to execute the Sub-PA on behalf of the respective Party, and that the Contractor and Participating Entity agree to be bound by the provisions hereof. In addition, Participating Entity represents that it has received the requisite approvals from the applicable Chief Procurement Official and NASPO to participate in the Agreement.

Section 9. Additional Terms and Conditions.

- **9.1 Application of PA.** The Parties acknowledge and agree that the terms and conditions of the PA are binding upon them.
- 9.2 Amendments to PA. The Parties acknowledge and agree that (a) Participating Entity has no right or authority to amend the PA; (b) any valid amendments or modifications to the PA and/or the Contract are automatically binding upon Participating Entity; and/or (c) in the event any such valid amendment or modification to the PA materially and adversely impacts Participating Entity, then Participating Entity may terminate the Sub-PA.
- Section 10. Order of Precedence. The Parties acknowledge and agree that in the event of a conflict between the terms contained in the various documents comprising the Agreement, the following order of precedence will control: (a) the Sub-PA; (b) the PA; (c) the Contract; and (d) any valid purchase order issued in connection therewith. This section specifically supersedes any order of precedence provisions set forth elsewhere in the Agreement.

Section 10.1 Activation Credits. AT&T will provide Participant either of the two activation credits as noted below in Table 10.1. An Activation Credit is only available to a Participating Entity's CRU who (a) activates a new two (2) year FirstNet Service on the corresponding, qualified Plan(s) within the first one hundred and eighty (180) days following the Effective Date of the Sub-PA, and (b) remain on Service under such Plan(s) at the time the Activation Credit is applied. No other CRU is eligible for an Activation Credit. CRUs activating new FirstNet Service after this 180-day period will not receive the Activation Credit. Activation Credits may not be combined with any other offers or activation credits. Qualified CRUs are only eligible for one Activation Credit. An Activation Credit may take up to two billing cycles to appear on the applicable invoice

Section 10.2 Upgrade Credits. AT&T will provide Participant with one of the following Upgrade Credits as noted in Table 10.2. An Upgrade Credit is only available to a Participating Entity's CRU who (a) upgrades to a new two (2) year FirstNet Service on the corresponding, qualified Plan(s) within the first one hundred and eighty (180) days following the Effective Date of the Sub-PA, and (b) remain on Service under such Plan(s) at the time the Upgrade Credit is applied. New CRUs activating new FirstNet Service after this 180-day period will not receive the Upgrade Credit. Upgrade Credits may not be combined with any other offers. Qualified CRUs are only eligible for one Upgrade Credit and are subject to the 18 month minimum upgrade period as set forth in Section 6. An Upgrade Credit may take up to two billing cycles to appear on the applicable invoice
