

RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, FOR PAYING AND REPORTING THE VALUE OF EMPLOYER PAID MEMBER CONTRIBUTIONS, EFFECTIVE NOVEMBER 2, 2018.

WHEREAS, the City Council of the City of Riverside has the authority to implement Government Code Section 20636(c)(4) pursuant to Section 20691; and

WHEREAS, the City Council of the City of Riverside has a written labor agreement which specifically provides for the normal member contributions to be paid for by the employer, and reported as additional compensation; and

WHEREAS, one of the steps in the procedures to implement Section 20691 is the adoption by the City Council of the City of Riverside of a Resolution to commence paying and reporting the value of said Employer Paid Member Contributions (EPMC); pursuant to CCR title 2 section 571(a)(1); and

WHEREAS, the City Council of the City of Riverside has identified the following conditions for the purpose of its election to pay EPMC:

- This benefit shall apply to all employees of the International Brotherhood of Electrical Workers Local 47 Utility Group and Local 47 Supervisory Group hired on or before October 18, 2011.
- This benefit shall consist of paying 4% of the normal member contributions as EPMC, and reporting the same percent (4%) as compensation earnable (excluding Government Code Section 20636(c)(4)) as additional compensation.
