Interim Assistant General Manager/Water Michael Plinski reported on the Iowa Avenue Transmission Main Replacement project and answered questions.

- 3. Approved the capital expenditure for Work Order No. 1903811 in the amount of \$2,140,000 which includes all design, construction, paving, contract administration, inspection and construction change order authority costs for the Iowa Avenue Transmission Main Replacement Project.

Assistant General Manager/Energy Delivery George Hanson reported on the Freeman Substation to Orangecrest Substation Fiber Optic Cable Upgrade and stressed the importance of this project upgrade which will replace the aged 12-strand fiber optic cable with the 144-strand standard fiber optic cable to improve the capacity, reliability and redundancy of the fiber optic network system between these two substations and answered questions from the Board.

Following discussion, the Board of Public Utilities approved Work Order No. 1423748 in the amount of \$1,265,000 to upgrade the fiber optic cable between Freeman and Orangecrest Substations to improve capacity and reliability.

Question 01:

We've received several comments related to the Land and Water Conservation Fund land conversion that is occurring within the Hidden Valley Wildlife Preserve. Can you, or someone involved in the process, provide an update on the status of the land conversion, including NEPA review? Please also indicate a schedule for the NEPA decision, if known.

Response to Question 01:

Riverside Public Utilities (RPU) and Southern California Edison (SCE) have proposed to construct the Riverside Transmission Reliability Project (RTRP), which will consist of both 69 kV and 230 kV electrical facilities, some of which would be located within and crossing over lands within the Hidden Valley Wildlife Area (HVWA). Because the affected HVWA lands were federally funded, in part, under Section 6(f)(3) of the Land and Water Conservation Fund Act (LWCF), conversion of these lands to non-recreation uses (e.g. electrical transmission line utility infrastructure) and the acquisition of "replacement" lands to offset these LWCF conversion impacts requires review and approval by the National Park Service (NPS). The LWCF State Assistance Program Manual (available here: https://www.nps.gov/subjects/lwcf/upload/iwcf manual.pdf) and the NPS require the submittal of a Project Description-Environmental Screening Form (PD-ESF) by the sponsoring agency (which is the Riverside County Regional Open Space District (District)), as well as appropriate National Environmental Policy Act (NEPA) environmental review. As sponsoring agency, the District has been consulting with the California Department of Fish and Wildlife-Wildlife Conservation Board (CDFW) because land within the District managed HVWA is also owned by CDFW. The California Department of Park and Recreation - Office of Grants and Locals Services (OGALS) which administers LWCF program within California, participated in the identification of replacement lands, and serves as liaison to the NPS for processing of the PD-ESF, as is described by the LWCF State Assistance Program Manual.

As stated in the PD-ESF and the LWCF State Assistance Program Manual, the LWCF conversion proposal environmental review properly focuses on the impacts from the loss of public outdoor recreation parkland and the replacement parkland proposed for same, and *not* the action precipitating the conversion or benefits thereof (in this case, the construction of an overhead electrical transmission line) beyond the boundary of the Section 6(f) boundary. The environmental review must 1) focus on "resource impacts" as indicated on the PD-ESF, and 2) the impacts of creating new replacement parkland and replacement recreation opportunities. The NPS ultimately approves or denies the conversion and replacement of LWCF lands after the Sponsoring Agency completes and submits the PD-ESF and NEPA related documentation that analyzes the effects of recreation land loss and replacement.

With respect to the land conversion currently being undertaken, SCE understands that POWER Engineers, Inc., on behalf of the District, has submitted two versions of the draft PD-ESF to OGALS for

review: on or about December 11, 2017 and on or about June 6, 2018. The PD-ESF details the proposed LWCF conversion and the replacement property's current conditions and potential impacts of the Section 6(f) land conversion. The PD-ESF has been reviewed by OGALS and approved for submission to the State. The PD-ESF is currently undergoing final review by CDFW.

Once CDFW approves the contents of the PD-ESF, the District intends to provide an opportunity to review and receive comments on the PD-ESF from the Riverside County Attorney, the Riverside Park District Advisory Commission, and the Riverside County Board of Supervisors. Following this final review, the District would submit the application (PD-ESF and supporting materials) to OGALS and NPS. The NPS would then review the draft PD-ESF for deficiencies and make a determination on the level of NEPA analysis (anticipated to be an Environmental Assessment (EA)) required for making a decision on the proposed Section 6(f) conversion and replacement lands. The NEPA analysis document would then be completed and attached to the final PD-ESF. Appropriate public review would be conducted by the NPS, and the NPS would then issue their decision (anticipated to be a Finding of No Significant Impact (FONSI)).

SCE currently anticipates the PD-ESF to be submitted to OGALS and NPS in or around November/December 2018. It is estimated that the NEPA analysis, review by the NPS, and public review will take approximately 9-12 months from the time of submittal of the final PD-ESF and EA to the NPS.

Hi all.

At Monday's Board of Public Utilities meeting, Board Member David Crohn voted twice on separate motions regarding Item #10 (Construction of 1,950 feet of new potable water pipeline of the Iowa Avenue 12-Inch Water Main Extension Project - ARB / ARB Headquarters for a total project cost of \$775,000 - Work Order No. 1905091 in the amount of \$256,000 and Work Order No. 1726679 in the amount of \$519,000), which makes infrastructure improvements at the expense of Riverside Public Utilities (RPU) general ratepayers to an area abutted by Mr. Crohn's employer, UCR. I confirmed with RPU General Manager Todd Jorgenson after the meeting that Phase IIB of this project (which would potentially service UCR's property) is completely discretionary at this time and in no way will impact the Air Resource Board's (ARB) service.

The staff report accompanying the item says, "University of California, Riverside's (UCR) Physical Master Plan identifies potential future expansion in this area." Mr. Crohn states at the meeting that, "it's going to be a very active and in-demand corridor once it's improved, and it's an area that has been targeted for development not just on the UCR side," and, "if future development happens and I think it will". In other words, UCR will financially benefit, in the form of increased property value, from these improvements. Further, I confirmed with GM Jorgenson after the meeting that any future development fees RPU would collect from UCR will not fully cover the cost of Phase IIB of this project.

I spoke over the phone with Board Member Crohn yesterday about his vote. He informed me that the City Attorney's Office (CAO) told him that there are special exemptions for State university professors from California's conflict-of-interest laws. As I am unaware of such, I ask that the CAO produce the foundation of this guidance now. I would also like to know why Phase IIB isn't considered a gift of public funds to UCR. It certainly smells like some of the games I see being played over in Moreno Valley with the World Logistics Center.

I would appreciate your help. However, if I don't get satisfactory and timely answers to my request, I will simply turn over whatever I have to the FPPC and the DA, and let them sort it all out.

Having researched the subject a bit further, I think the Government Code Section of importance here is 1091.

1091. (a) An officer shall not be deemed to be interested in a contract entered into by a body or board of which the officer is a member within the meaning of this article if the officer has only a remote interest in the contract and if the fact of that interest is disclosed to the body or board of which the officer is a member and noted in its official records, and thereafter the body or board authorizes, approves, or ratifies the contract in good faith by a vote of its membership sufficient for the purpose without counting the vote or votes of the officer or member with the remote interest.

(b) As used in this article, "remote interest" means any of the following:

(13) That of a person receiving salary, per diem, or reimbursement for expenses from a government entity.

As I chronicled in my previous email to you, you were the deciding vote on Mr. Foust's motion that failed, which would have protected Riverside's ratepayers. In was clear in both staff's report and your own oral comments at the meeting September 24th that UCR - your employer - would financially benefit from Phase IIB of this project. However, you did not disclose your interest openly. It is my interpretation of the code that any contract emanating from the decision to go forward with Phase IIB is voidable.

My suggestion to RPU is that a new vote needs to be taken on Mr. Foust's motion at the next Board meeting. If that were to happen, I would consider the situation remedied and pursue it no further.
