1 ORDINANCE NO. 2 AN ORDINANCE OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING CHAPTER 3.30 OF THE RIVERSIDE MUNICIPAL CODE, 3 TO ADD ADDITIONAL CATEGORIES TO THE SCHEDULE OF REGULATION, PRODUCTS, AND SERVICES 4 5 The City Council of the City of Riverside does ordain as follows: 6 Section 1: Section 3.30.030 of the Riverside Municipal Code is amended as follows: 7 "Section 3.30.030 Schedule of Regulation, Products and Services. 8 The City Clerk, City Manager, Chief Finance Officer and each City department head, 9 under the direction of the City Manager, shall review annually the regulations, products and services 10 of the City and the fees and service charges imposed by the City or recommended to be imposed by 11 the City, and provide an adjusted fee or charge schedule to the City Council for its consideration so 12 as to recover the percentage of costs reasonably borne as set forth in the Master Fees and Charges 13 Schedule as necessary to provide the listed regulation, product or service: 14 **Regulation, Product or Service** 15 16 V. **CITY-WIDE ACTIVITIES:** 17 18 2929 Bicycle Equipment/Facilities Rental 19 ...; 20 Section 2: The City Council has reviewed the matter and, based upon the facts and 21 information contained in the staff reports, administrative record, and written and oral testimony, 22 hereby finds that this ordinance is not subject to CEQA pursuant to Sections 15060(c)(2), 23 15060(c)(3) and/or 15061(b)(3) of the State CEQA Guidelines, California Code of Regulations, Title 24 14, Chapter 3, in that it will not result in a direct or reasonably foreseeable indirect physical change 25 in the environment nor have a significant impact on the environment. 26 Section 3: The City Clerk shall certify to the adoption of this ordinance and cause

publication once in a newspaper of general circulation in accordance with Section 414 of the Charter
