RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, CONFIRMING THE ANNUAL REPORT OF THE RIVERSIDE DOWNTOWN PARTNERSHIP ACTING IN ITS CAPACITY AS THE ADVISORY BOARD TO THE DOWNTOWN PARKING AND BUSINESS IMPROVEMENT AREA AND LEVYING ASSESSMENTS FOR CALENDAR YEAR 2019.

WHEREAS, the City Council of the City of Riverside at its meeting on October 9, 2018, adopted Resolution No. 23370 stating its intention to hold a public hearing on November 6, 2018, to hear and consider protests to the annual levying of assessments for the Downtown Parking and Business Improvement Area; and

WHEREAS, the City Council has held a public hearing and heard, considered, and ruled on all written and oral protests to the imposition of the annual levy.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, pursuant to Section 36535 of the California Streets & Highways Code, as follows:

- 1. The annual report of the Riverside Downtown Partnership, acting in its capacity as the advisory board to the Downtown Parking and Business Improvement Area, is hereby confirmed.
- 2. The levy of assessments for the Downtown Parking and Business Improvement Area is hereby imposed for calendar year 2019 on each business entity within the Area at the rate of one hundred percent (100%) of the non-discounted business tax charge paid by the entity, as set forth in Riverside Municipal Code 3.46.060, without regard to any incentive or early payment discounts which may be offered at any given time, and which shall provide specific

1 services and benefits directly to each business entity within the Area subject to the assessment
2 at a cost which does not exceed the reasonable cost in providing the services and benefits.
