ORDINANCE NO.

AN ORDINANCE OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING SECTION 10.52.220 OF THE RIVERSIDE MUNICIPAL CODE TO ENABLE TOWING WITHIN CURBSIDE PASSENGER LOADING ZONES.

The City Council of the City of Riverside does ordain as follows:

<u>Section 1:</u> Section 10.52.220 of the Riverside Municipal Code is hereby amended in its entirety as follows:

Section 10.52.220 Curbside passenger loading zones.

No person shall stop, stand, or park a vehicle for any purpose or period of time, other than for the expeditious loading or unloading of passengers or for depositing mail in an adjacent mailbox, in any place marked as a curbside passenger loading zone or where there are white curb markings, and then only for a period not to exceed three minutes.

Where there are signs posted indicating the hours during which parking is not permitted at the white curb, no vehicle may stop, stand, or park in a curbside passenger loading zone marked by a white curb for longer than three minutes during those posted hours. Vehicles may be towed when passenger loading zone signs include notice that vehicles may be removed.

Section 2: The City Council has reviewed the matter and, based upon the facts and information contained in the staff reports, administrative record, and written and oral testimony, hereby finds that this ordinance is not subject to CEQA pursuant to Sections 15060(c)(2), 15060(c)(3) and/or 15061(b)(3) of the State CEQA Guidelines, California Code of Regulations, Title 14, Chapter 3, in that it will not result in a direct or reasonably foreseeable indirect physical change in the environment nor have a significant impact on the environment.

Section 3: The City Clerk shall certify to the adoption of this ordinance and cause publication once in a newspaper of general circulation in accordance with Section 414 of the Charter of the City of Riverside. This ordinance shall become effective on the 30th day after the date of its adoption.
