This FIRST AMENDMENT TO OFFICIAL POLICE TOW TRUCK SERVICE AGREEMENT ("First Amendment") is made and entered into this _____ day of _____, 2018, by and between the CITY OF RIVERSIDE, a California charter city and municipal corporation ("City") and WHITE HOUSE ENTERPRISES, INC., a California corporation doing business as PATRIOT TOWING (hereinafter referred to as "Contractor"), with respect to the following facts:

RECITALS

WHEREAS, on or about December 12, 2016, City and Contractor entered into the Official Police Tow Truck Service Agreement for Contractor to perform vehicle towing and storage services for the City's Police Department pursuant to the terms and conditions stated therein ("Agreement"); and

WHEREAS, Section G, subsections (1) and (2) of the Agreement states that the Agreement term shall expire on January 1, 2019 unless renewed for a subsequent Renewal Term of one (1) year; and

WHEREAS, City and Contractor desire to amend the Agreement and renew the term for one (1) year to expire December 31, 2019.

- 1. The Agreement Term shall be extended for one (1) year, with a new expiration date of December 31, 2019.
- 2. All terms and conditions of the Agreement not inconsistent with this First Amendment shall remain in full force and effect and are incorporated herein by this reference as if set forth in full.
