BE RECORDED AS AN EXCUSED OR UNEXCUSED ABSENCE

ISSUE:

Determine whether Commissioner Scarano, Tavaglione, Plascencia, Segura, Mackenroth, and Lee's absence on May 31, 2018, should be recorded as an excused or unexcused absence.

RECOMMENDATIONS:

That the Budget and Engagement Commission (BEC) determine if:

- 1. Commissioner Scarano's absence from the Budget Engagement Commission meeting on May 31, 2018, be excused or unexcused;
- 2. Commissioner Tavaglione's absence from the Budget Engagement Commission meeting on May 31, 2018, be excused or unexcused;
- 3. Commissioner Plascencia's absence from the Budget Engagement Commission meeting on May 31, 2018, be excused or unexcused;
- 4. Commissioner Segura's absence from the Budget Engagement Commission meeting on May 31, 2018, be excused or unexcused;
- 5. Commissioner Mackenroth's absence from the Budget Engagement Commission meeting on May 31, 2018, be excused or unexcused; and
- 6. Commissioner Lee's absence from the Budget Engagement Commission meeting on May 31, 2018, be excused or unexcused.

BACKGROUND:

The attendance policy for the BEC is governed by Riverside City Resolution 23035 Section XIV – Boards, Commissions, and Committees, and by BEC Bylaws Article XI adopted on February 22, 2018.
