## **RESOLUTION NO.**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING RESOLUTION NO. 22451 KNOWN AS THE MASTER PARKING SCHEDULE RESOLUTION TO REVISE THE EXISTING 30-MINUTE PARKING ZONE DURATION ON MARKET STREET.

WHEREAS, the Public Works Department received a request from the Riverside Food Lab located at 3605 Market Street to revise the existing 30-Minute Parking zone at the frontage of its facility along Market Street south of Sixth Street to extend the effective hours and days; and

9 WHEREAS, revising the existing 30-Minute Parking Zone will better serve the high 10 volume of patrons picking up food and/or drinks from one or more of Riverside Food Lab's 14 11 eateries and bars by providing easily accessible short-term parking at the front of the building 12 during all days and hours of operation; and

WHEREAS, expanding the duration of the existing 30-Minute Parking zone at the frontage of the Riverside Food Lab will provide greater convenient short-term parking options throughout the facility and better meet the current needs of the Riverside Food Lab and their patrons; and

WHEREAS, nearby longer-term 90-Minute parking will continue to be available on both
sides of Sixth Street west of Market Street, on the west side of Market Street north of Sixth Street,
and on Fairmount Boulevard between Sixth Street and Mission Inn Avenue, in addition to first
90-Minute free parking available within adjacent Garage 7.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
California, as follows:

"30-Minute Parking zone on the west side of Market Street from Sixth Street to Mission Inn
Avenue to change the zone duration from "9:00 a.m. to 5:00 p.m. except Saturday, Sunday, and
holidays" to "6:00 a.m. to 10:00 p.m. Daily".
