James Stream was the Executive Director for The Arc of Riverside County from 1988 until his untimely death in June, 2017. Jim was a leading advocate and pioneered many important initiatives to improve the quality of life for people with intellectual and other disabilities. He was also engaged in efforts to promote and improve the quality of life in his home community of Riverside. The National Wall of Respect, which he envisioned and built, represents a beautiful mosaic pictorial of inclusive activities here in the City of Riverside.
