

## **FOURTH AMENDMENT TO LEASE AGREEMENT**

**LIVEU, INC.**

**(Rental of Software and Hardware Equipment for Uplink Solution)**

THIS FOURTH AMENDMENT TO LEASE AGREEMENT ("Amendment") is made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, 2018, by and between the CITY OF RIVERSIDE, California, a California charter city and municipal corporation, and LiveU, Inc., a Delaware corporation duly authorized to do business in California, with its principal offices at 2 University Plaza Drive, Hackensack, NJ 07601 ("LiveU"), amending the Lease Agreement for Rental of Software and Hardware Equipment for Uplink Solution is hereby amended as described below.

### **RECITALS**

WHEREAS, on or about September 14, 2011, the City and LiveU entered into a Lease Agreement for the rental of hardware and software equipment ("Agreement"); and

WHEREAS, on or about June 1, 2014, Customer and LiveU entered into a First Amendment to the Agreement; and

WHEREAS, on or about April 1, 2016, Customer and LiveU entered into a Second Amendment to the Agreement; and

WHEREAS, on or about March 31, 2018, the renewal under Purchase Order 180252 expired; and

WHEREAS, the City continues to need and use the goods and services provided under the Agreement;

WHEREAS, the City is satisfied with the performance of LiveU under the Agreement; and

WHEREAS, the City and LiveU desire to continue the goods and services under the Agreement;

The parties hereby agree as follows:

**1. Amendment Expiration.** Exhibit 1 of the Agreement is amended as follows:

- a. Section 1. "LiveU Solution Description" is amended to state that the LU70 has been upgraded to LU500.

b. Section 2. The Rental Period described in Exhibit 1 to the Agreement is hereby extended until and including June 30, 2020.

2. **Amendment Effective Date.** The effective date of this Amendment is April 1, 2018.

3. Except as amended by this Amendment, all terms under the Agreement remain unchanged and in full force and effect.

IN WITNESS WHEREOF, Customer and LiveU have caused this Fourth Amendment to Agreement for rental of hardware and software equipment to be duly executed and effective as of April 1, 2018.



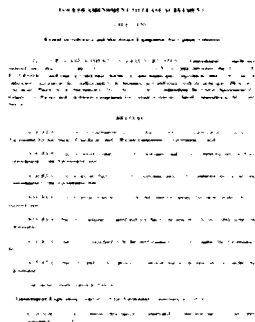


