SUBJECT: REQUEST FOR PROPOSAL NO. 1776 FOR ENGINEERING SERVICES PANEL - MASTER PROFESSIONAL CONSULTANT SERVICES AGREEMENTS WITH 35 FIRMS FOR VARIOUS ENGINEERING SERVICES FOR PUBLIC WORKS CAPITAL IMPROVEMENT PROJECTS IN AN AMOUNT NOT TO EXCEED \$750,000 EACH FOR A THREE-YEAR PERIOD THROUGH DECEMBER 31, 2021

ISSUE:

Approve Master Professional Consultant Services Agreements with 35 firms for various engineering services for Public Works capital improvement projects for a three-year period through December 31, 2021, not to exceed \$750,000 per engineering firm.

RECOMMENDATIONS:

That the City Council:

- Approve the Master Professional Consultant Services Agreements with 35 firms for various engineering services for Public Works capital improvement projects, not to exceed \$750,000 per firm, with an initial term of three years through December 31, 2021, and two optional one-year extensions;
- 2. Authorize the City Manager, or his designee, to execute the Master Professional Consultant Services Agreements; and
- 3. Authorize the City Manager, or his designee, to execute project Supplemental Agreements as-needed under the Master Agreement up to \$750,000 per firm over the agreement term.

BACKGROUND:

The Public Works Department has successfully deployed consultant panels in the past to streamline processes. On July 14, 2009, the City Council approved on-call Master Professional Services Agreements for environmental, civil engineering, traffic engineering, construction management, and landscape architecture with 28 consulting firms to assist the Public Works Department with various capital improvement projects (CIP) on an as-needed basis through December 31, 2011.

Between 2012 and 2018, the Public Works Department utilized City engineering staff to design most small and large CIP Projects.

With the recent passage of Measure Z and Senate Bill 1, the Public Works Department receives approximately \$8.3M in increased annual funding for roadway maintenance and CIP projects. These new funding sources allow the Public Works Department to design and construct additional projects. As staffing levels remain unchanged, an Engineering Services Panel is needed to augment staff to complete many of these projects in a timely manner.

DISCUSSION:

<u>RFP 1776</u>

On February 2, 2018, the Public Works Department issued a Request for Proposals (RFP No. 1776) seeking qualified consultants to provide professional services related to Civil Engineering Design; Construction Inspection and Management; Environmental Engineering Services; Geotechnical Engineering and Materials Testing; Landscape Architecture; Structural Engineering Design; Land Surveying; and Traffic Engineering, on an on-call basis.

On March 20, 2018, the Public Works Department received 83 proposals. A selection panel comprised of nine Public Works Department staff members reviewed the proposals and selected 35 consulting firms as the most qualified to perform the required services (Table 1).

The Master Consultant Services Panel will augment staff by providing engineering services on an as-needed basis for Public Works capital improvement projects valued at less than \$500,000. For larger and more complex projects, typically projects with an engineer's estimated project value of \$500,000 or more, staff would use the City's standard formal bidding process. Each consulting firm on the panel could be utilized for more than one project, as long as the cumulative amount for all combined projects does not exceed \$750,000 per firm.

Engineering companies on the panel are pre-qualified to provide proposals for individual projects. The Public Works Department will solicit proposals from all pre-qualified consultant firms within their respective categories of expertise. A Public Works Department review panel will select the best proposal based on project approach, strength of the proposed project team, cost, and schedule. Funds for each assigned project are included as part of the two-year budget and Capital Improvement Project budget adoption. Public Works will negotiate a Supplemental Agreement with the selected firm for each project, including scope and fee.

Master Panel Agreements

The term of each Master Agreement is three years, with two optional one-year extensions, in an amount not to exceed \$750,000 per firm. Each consultant has been pre-qualified based on their area of expertise and RFP results into one or more of the following eight categories:

- 1. Civil Engineering Design (CED) Street, Storm Drain, and Sewer Design
- 2. Construction Inspection and Management (CIM)
- 3. Environmental Engineering Services(EES)
- 4. Geotechnical Engineering and Materials Testing (GEMT)
- 5. Landscape Architecture (LA)
- 6. Structural Engineering Design (SED)
- 7. Land Surveying (LS)
