STATE LANDMARK DESIGNATION - No update

MUSEUM BOARD REPORT - No January 2019 Metropolitan Museum Board meeting was held. The Museum Board will discuss dissolution of the HHPC as a Museum Board ad hoc committee at its February meeting.

HARADA HOUSE

Director Peterson distributed a letter that was mailed to lead Robinson House campaign donors with updates from 2018. The Museum will go to Council February 5, 2019 for permission to apply for \$3 million in Proposition 68 funding; the application is due February 13. Museum staff are drafting the Museum's next five-year strategic plan that will begin July 1, 2019; four Harada objectives are included.

ROBINSON HOUSE PRESERVATION / CDBG

Due to the government shutdown, approval from HUD for the CDBG funding was delayed. Estimated timeline is to break ground by the end of spring 2019 and complete renovation within six months.

HARADA HOUSE FOUNDATION (HHF)

A grant in the amount of \$15,000 was received, and a request for qualifications was distributed. The deadline for responses is in two weeks. Options for the approach to rehabilitation of the house and costs that will give the fundraising campaign its scope should be available by the end of July 2019.

FUTURE AGENDA ITEMS

A recommendation was approved for the HHPC to meet bi-monthly on the 1st Friday at 10:00 a.m. starting in April 2019.
