#### 3. Riverside Museum Associates (RMA)

RMA President Robin Whittington reported that yard sale profits from surplus items was estimated at \$300, with surplus items being posted online. The Multicultural Council Day of Inclusion was held Saturday, December 8, at the Cesar Chavez Community Center with 150 guests in attendance. The annual Heritage House Victorian Christmas Open House saw approximately 2,500 visitors to the event on December 9.

### 4. Harada House Foundation (HHF)

A private foundation grant in the amount of \$15,000 will allow the HHF to obtain three proposals from historic preservation architects for rehabilitation of Harada House. An RFQ will be issued soon for firms to apply.

# 5. Director's update regarding administration and budget, staffing, collections, facilities, main museum renovation, exhibitions and programs, and community engagement

In addition to the written report, Director Peterson reported that the Tlatilco exhibition at the Riverside Art Museum closes December 30. Radio ads will run on 99.1KGGlfm during the last two weeks. The Museum has participated in First Sundays for the past three months. Riverside is the only California city to host a Day of Inclusion event continuously since its

designation in 2009. Architecture firm interviews are in process for the Main Museum RFP. An application for Prop. 68 grant funds in support of Harada House will be filed. NAGPRA repatriations are in progress with anticipated completion the end of winter 2019. Measure Z funds in the amount of \$1.3 million transferred from the Museum to the Main Library will not be returned to the Museum department. The Museum's new Curator of Natural History Dr. Douglas Long will begin in February 2019.
