The purpose of the funding is to allow us to purchase 200 noodles for children participants. The objective of the program is to bring awareness to children and others about drowning by teaching them the “Starfish Technique”: floating on either their stomach or back with arms and legs spread apart in the position of a starfish.

Describe the overall contribution of the festival, special event, community project or program to the community in relation to the goals and objectives of the Human Relations Commission:

The overall contribution of the Splish Splash Water Safety/Swim Program is to include city participants in an affordable water safety program that would not otherwise include their participation because of their inability to pay for these services. The goals and objectives of Riverside HRMC is to ensure that these city participants are included on a consistent basis.

What are the measurable target objectives that will be used to determine the success of the festival, special event, community project or program? 1. First Year 2016 Surveys indicated a 100% satisfaction with the results of the program event in fulfilling a much-needed service in the city and community.
2. Second Year 2017: Surveys indicated a 100% satisfaction with results of the event in addressing a vital need in the city and community.
3. Third Year 2018: Surveys indicated a 100% satisfaction of the event program and indicated the desire to have the program expanded to accommodate a larger population in the city and community.:
