

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,
3 CALIFORNIA, AMENDING RESOLUTION NO. 22451 KNOWN AS THE
4 MASTER PARKING SCHEDULE RESOLUTION TO ESTABLISH A NO
PARKING ZONE ON ROYAL PALM BOULEVARD.

5 WHEREAS, the Public Works Department received a petition from eighty (80%) percent
6 of residents on Royal Palm Boulevard requesting the establishment of a “No Parking between the
7 hours of 8 p.m. to 6 a.m. Daily” zone along the entirety of the cul-de-sac at the southwesterly
8 termination of Royal Palm Boulevard; and

9 WHEREAS, residents indicate that nighttime parking generates undesirable and illicit
10 activity as well as noise and safety concerns for residents; and

11 WHEREAS, the establishment of the proposed no parking zone would restrict late night
12 and early morning parking along the entirety of the cul-de-sac at the southwesterly termination of
13 Royal Palm Boulevard; and

14 WHEREAS, on February 6, 2019, the Transportation Board unanimously recommended
15 the establishment of a “No Parking between the hours of 8:00 p.m. to 6:00 a.m. Daily” zone along
16 the entirety of the cul-de-sac at the southwesterly termination of Royal Palm Boulevard.

17 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
18 California, as follows:

19 Section 1: The recitals set forth above are incorporated herein by reference.

20 Section 2: That the Master Parking Schedule is hereby amended by establishing a “No
21 Parking between the hours of 8:00 p.m. to 6:00 a.m. Daily” zone along the entirety of the cul-de-
22 sac at the southwesterly termination of Royal Palm Boulevard.

23 Section 3: That the provisions of this resolution shall be operative only when signs are
24 erected on that portion of the street set forth in Section 2 above, giving notice of the parking
25 limitations or prohibitions herein established.

26 Section 4: The provisions of this amendment shall be operative as of the date of adoption
27 of this resolution.
