A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING RESOLUTION NO. 22451 KNOWN AS THE MASTER PARKING SCHEDULE RESOLUTION TO ESTABLISH A NO PARKING ZONE ON ROYAL PALM BOULEVARD.

WHEREAS, the Public Works Department received a petition from eighty (80%) percent of residents on Royal Palm Boulevard requesting the establishment of a "No Parking between the hours of 8 p.m. to 6 a.m. Daily" zone along the entirety of the cul-de-sac at the southwesterly termination of Royal Palm Boulevard; and

WHEREAS, residents indicate that nighttime parking generates undesirable and illicit activity as well as noise and safety concerns for residents; and

WHEREAS, the establishment of the proposed no parking zone would restrict late night and early morning parking along the entirety of the cul-de-sac at the southwesterly termination of Royal Palm Boulevard; and

WHEREAS, on February 6, 2019, the Transportation Board unanimously recommended the establishment of a "No Parking between the hours of 8:00 p.m. to 6:00 a.m. Daily" zone along the entirety of the cul-de-sac at the southwesterly termination of Royal Palm Boulevard.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, as follows:

<u>Section 1</u>: The recitals set forth above are incorporated herein by reference.

<u>Section 2</u>: That the Master Parking Schedule is hereby amended by establishing a "No Parking between the hours of 8:00 p.m. to 6:00 a.m. Daily" zone along the entirety of the cul-desac at the southwesterly termination of Royal Palm Boulevard.

<u>Section 3</u>: That the provisions of this resolution shall be operative only when signs are erected on that portion of the street set forth in Section 2 above, giving notice of the parking limitations or prohibitions herein established.

<u>Section 4</u>: The provisions of this amendment shall be operative as of the date of adoption of this resolution.
