ORDINANCE NO. 1 AN ORDINANCE OF THE CITY OF RIVERSIDE, CALIFORNIA, 2 AMENDING CHAPTER 5.08.040 OF THE RIVERSIDE MUNICIPAL CODE REGARDING THE HOURS OF SOLICITATION. 3 4 The City Council of the City of Riverside does ordain as follows: 5 Section 5.08.040 of the Riverside Municipal Code is hereby amended as Section 1: 6 follows: 7 "No person shall engage in any form of door to door solicitation before 8:00 a.m. or after 8 9 7:00 p.m. Further, it shall be unlawful for any person to engage in solicitation at any 9 time of day if such time of day is clearly posted on the "no soliciting" sign posted 10 pursuant to the sections of this Code." 11 The City Council has reviewed the matter and, based upon the facts and Section 2: 12 information contained in the staff reports, administrative record, and written and oral testimony, 13 hereby finds that this ordinance is not subject to CEQA pursuant to Sections 15060(c)(2), 14 15060(c)(3) and/or 15061(b)(3) of the State CEQA Guidelines, California Code of Regulations, Title 15 14, Chapter 3, in that it will not result in a direct or reasonably foreseeable indirect physical change 16 in the environment nor have a significant impact on the environment. 17 Section 3: The City Clerk shall certify to the adoption of this ordinance and cause 18 publication once in a newspaper of general circulation in accordance with Section 414 of the Charter 19 of the City of Riverside.
