ORDINANCE NO. 1 AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF 2 RIVERSIDE, CALIFORNIA, AMENDING TITLES 8 AND 19 OF THE RIVERSIDE MUNICIPAL CODE. 3 The City Council of the City of Riverside does ordain as follows: 4 Section 8.18.010 of the Riverside Municipal Code is hereby amended as Section 1: 5 follows: 6 "Unless it is apparent from the context that another meaning is intended, the following 7 words, when used herein, shall have the meaning ascribed by this section. 8 Commercial cattery shall have the same meaning as "Cattery-Commercial" as defined in 9 Chapter 19.910 Definitions, of the Municipal Code. 10 Commercial kennel shall have the same meaning as "Kennel-Commercial" as defined in Chapter 19.910 Definitions, of the Municipal Code. 11 Residential cattery shall have the same meaning as "Cattery-Residential" as defined in 12 Chapter 19.910 Definitions of the Municipal Code. 13 Residential kennel shall have the same meaning as "Kennel-Residential" as defined in 14 Chapter 19.910 Definitions of the Municipal Code." 15 Sections 19.150.020, 19.910.040, 19.910.050, and 19.910.120 and Chapter Section 2: 16 19.270 of the Riverside Municipal Code are hereby amended as set forth in Exhibit "A" attached 17 hereto and incorporated herein by reference. 18 Section 3: The City hereby finds that this ordinance is not subject to review under the 19 California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines sections 15060, 20 subdivision (c)(2) (the activity will not result in a direct or reasonably foreseeable indirect physical 21 change in the environment) and 15061, subdivision (b)(3) (there is no possibility the activity in 22 question may have a significant effect on the environment). In addition to the foregoing general 23 exemptions, the City Council further finds that this ordinance is categorically exempt from review 24 under CEQA under the Class 8 Categorical Exemption (regulatory activity to assure the protection of 25 the environment), CEQA Guidelines section 15308. 26 /// 27
