

ORDINANCE NO.

AN ORDINANCE OF THE CITY OF RIVERSIDE, CALIFORNIA,
AMENDING SECTION 2.04.010 OF THE RIVERSIDE MUNICIPAL
CODE REVISING THE MEETING SCHEDULE OF THE CITY COUNCIL.

The City Council of the City of Riverside does ordain as follows:

Section 1: Section 2.04.010 of the Riverside Municipal Code is hereby amended in its entirety and replaced with the following:

Section 2.040.010 Time of regular meetings.

~~Except for the months of July and August, t~~The regular meetings of the Mayor and City Council shall be held on the first, second, and third and fourth Tuesdays of each month at the approximate hour of 2:00 p.m., which time is subject to change. During the months of July and August, the regular meetings shall be held on the second and fourth Tuesdays of said months at the approximate hour of 2:00 p.m., and said Mayor and City Council shall not have regular meetings on the first and third Tuesdays of said months. There shall be no meeting held on any Tuesday immediately following a City observed holiday occurring on a Monday.

Section 2: The City Council has reviewed the matter and, based upon the facts and information contained in the staff reports, administrative record, and written and oral testimony, hereby finds that this ordinance is not subject to CEQA pursuant to Sections 15060(c)(2), 15060(c)(3) and/or 15061(b)(3) of the State CEQA Guidelines, California Code of Regulations, Title 14, Chapter 3, in that it will not result in a direct or reasonably foreseeable indirect physical change in the environment nor have a significant impact on the environment.

Section 3: The City Clerk shall certify to the adoption of this ordinance and cause publication once in a newspaper of general circulation in accordance with Section 414 of the Charter of the City of Riverside. This ordinance shall become effective on the 30th day after the date of its adoption.
