#### **PRESENTATION**

4. Presenters from North and Norte Vista were unresponsive to commissioner outreach and once again did not attend meeting to make presentation

#### **DISCUSSION AND ACTION CALENDAR:**

 Commission considered application from the Vivian Stancil Olympian Foundation, Inc. in the amount of \$200 for pool noodles for the Splish Splash Water Safety on April 27, 2019

Commissioner Mabon moved to approve, 2<sup>nd</sup> by J. McNulty Motion Carried Unanimously, Commissioner Stancil Abstained

- 6. The ad hoc committee for scholarships did not meet ahead of the March 21 meeting, so the commission as a whole discussed options for scholarship criteria. Commissioner Mabon recommended essays and a 2.0 GPA minimum. Commissioners Scoggins and D. McNulty advocated for a reduced GPA requirement or no GPA requirement. Commissioner Ahmed recommended reaching out to each school district with basic purpose/goal of scholarship and dollar amounts and allowing the school boards to choose awardees. A general discussion followed with commissioners generally agreeing that the less restrictive, the better, so as to stay in line with the HRC's values of inclusivity and equality. Commissioner Mabon motioned to offer scholarships with no GPA requirement, using an essay/creative writing of any type contest, allowing the executive committee to create flyers and approve for promotion to move forward quickly. Commissioner Stancil 2<sup>nd</sup>. Motion Carried Unanimously
- 7. Commissioner Scoggins gave a report on the Color of Law event at La Sierra University. She learned quite a bit from the main speaker, particularly on the history of federally subsidized housing projects and their initial purpose of housing middle class families. Commissioner J. McNulty motioned to approve reimbursement of the cost of the seminar in the amount of \$25.00. Commissioner Armster 2<sup>nd</sup>. Motion Carried Unanimously
- 8. Chair Rush recommended drafting a letter to each organization that maintains the statues on the mall to inform them that they could apply for funds to repair damaged or vandalized statues. Commissioner Wright recommended starting a long-term fund to raise a larger amount of money that could be place on reserve rather than sending small amounts each time it occurs. Chair Rush agreed that would be a better long-term approach and asked to discuss at a later meeting. Commissioner Ahmed motioned for Chair Rush to draft the letters and staff to distribute them.
