

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
3 RIVERSIDE, CALIFORNIA, AUTHORIZING THE CITY MANAGER,  
4 ASSISTANT CITY MANAGERS, DEPUTY CITY MANAGERS AND THE  
5 COMMUNITY & ECONOMIC DEVELOPMENT DIRECTOR TO ACCEPT  
6 CONVEYANCES TO THE CITY OF RIVERSIDE OF INTERESTS IN  
7 REAL PROPERTY AND CONSENT TO THE RECORDATION OF SUCH  
8 INSTRUMENTS AND CONSENT TO THE RECORDATION OF OFFERS  
9 OF DEDICATION; AND REPEALING RESOLUTION NO. 21027.

10 WHEREAS, the City Council of the City of Riverside adopted Resolution No. 21027  
11 authorizing the City Manager, Assistant City Managers, Development Director or the Real Property  
12 Manager to accept for and on behalf of the City of Riverside ("City"), all deeds or grants conveying  
13 any interest in real property to the City, and the consent to the recordation of all irrevocable offers of  
14 dedication to the City; and

15 WHEREAS, the Development Department has since merged into the Community &  
16 Economic Development Department; and

17 WHEREAS, the City desires to revise the authority for the continued smooth acceptance of  
18 real property interests and consent to the recordation of irrevocable offers of dedication.

19 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,  
20 California, as follows:

21 Section 1: That from and after the date of adoption of this Resolution, all deeds and/or  
22 grants conveying to the City for public purposes any interest in or easement upon real property may  
23 be accepted for and on behalf of the City by its City Manager, any of its Assistant City Managers or  
24 Deputy City Managers, or the Community & Economic Development Director, and that the written  
25 acceptance of such deeds or grants by the City Manager, Assistant City Manager, Deputy City  
26 Manager or the Community & Economic Development Director on behalf of the City shall also  
27 constitute the consent of the City to the recordation of such instruments.

28 Section 2: That from and after the date of adoption of this Resolution the recordation of  
all irrevocable offers of dedication to the City of real property for any public purpose, including but  
not limited to, streets, highways, paths, alleys, including access rights and abutters' rights, drainage,  
open space, public utility or other public easements, parks, or other public places, may be consented

1 to on behalf of the City by its City Manager, any of its Assistant City Managers or Deputy City  
2 Managers, or the Community & Economic Development Director.

3 Section 3: The City Clerk of the City, upon adoption of this Resolution, is hereby  
4 authorized and directed to transmit to the County Recorder of Riverside County, a certified copy of  
5 this Resolution for recordation in the office of said County Recorder.

6 Section 4: Resolution No. 21027 is hereby repealed in its entirety.
