2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
3 RIVERSIDE, CALIFORNIA, AUTHORIZING ITS CITY MANAGER,
4 ASSISTANT CITY MANAGERS, DEPUTY CITY MANAGERS AND
5 COMMUNITY & ECONOMIC DEVELOPMENT DIRECTOR TO
EXECUTE RIGHT-OF-WAY CERTIFICATIONS FOR PROJECTS
UTILIZING STATE AND/OR FEDERAL FUNDS, AND REPEALING
RESOLUTION NO. 21028.

6 WHEREAS, on September 6, 2005, the City Council of the City of Riverside adopted
7 Resolution No. 21028 authorizing the City Manager, Assistant City Managers, Development
8 Director or Real Property Manager to execute Right-of-Way Certifications for projects utilizing state
9 and/or federal funds; and

10 WHEREAS, the Development Department has since merged into the Community &
11 Economic Development Department; and

12 WHEREAS, the City desires to revise the authorization and delegation for the certification of
13 right-of-way projects involving state and/or federal funds.

14 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
15 California, as follows:

16 Section 1: That from and after the date of adoption of this Resolution, Right-of-Way
17 Certifications for projects utilizing state and/or federal funds may be executed on behalf of the City
18 of Riverside by any of the following: City Manager, Assistant City Manager, Deputy City Manager
19 or Community & Economic Development Director.

20 Section 2: Resolution No. 21028 is hereby repealed.
