## **RESOLUTION NO.**

A RESOLUTION OF THE HOUSING AUTHORITY OF THE CITY OF **EXECUTIVE** RIVERSIDE. CALIFORNIA, AUTHORIZING ITS DIRECTOR, AND THE ASSISTANT CITY MANAGERS, DEPUTY CITY MANAGERS AND THE COMMUNITY & ECONOMIC DEVELOPMENT OF THE CITY RIVERSIDE DIRECTOR OF TO ACCEPT CONVEYANCES TO THE HOUSING AUTHORITY OF INTERESTS IN REAL PROPERTY AND CONSENT TO THE RECORDATION OF SUCH INSTRUMENTS; AND REPEALING SECTION 7 OF RESOLUTION NO. 2.

<u>Section 2</u>: The Secretary of the Housing Authority, upon adoption of this Resolution, is hereby authorized and directed to transmit to the County Recorder of Riverside County, a certified copy of this Resolution for recordation in the office of said County Recorder.
