2 A RESOLUTION OF THE HOUSING AUTHORITY OF THE CITY OF
3 RIVERSIDE, CALIFORNIA, AUTHORIZING ITS EXECUTIVE
4 DIRECTOR, AND THE ASSISTANT CITY MANAGERS, DEPUTY CITY
5 MANAGERS AND THE COMMUNITY & ECONOMIC DEVELOPMENT
6 DIRECTOR OF THE CITY OF RIVERSIDE TO ACCEPT
CONVEYANCES TO THE HOUSING AUTHORITY OF INTERESTS IN
REAL PROPERTY AND CONSENT TO THE RECORDATION OF SUCH
INSTRUMENTS; AND REPEALING SECTION 7 OF RESOLUTION NO.
2.

7 WHEREAS, on December 16, 2009, the Housing Authority of the City of Riverside adopted
8 Resolution No. 2 authorizing, among other things, that its Executive Director or his designee, the
9 authority to accept for and on behalf of the Housing Authority, all deeds or grants conveying any
10 interest in real property to the Housing Authority, including the recordation of the same; and

11 WHEREAS, the Housing Authority desires to revise the authority for the continued smooth
12 acceptance of real property interests and the recordation of the same.

13 NOW, THEREFORE, BE IT RESOLVED by the Housing Authority of the City of
14 Riverside, California, as follows:

15 Section 1: That from and after the date of adoption of this Resolution, all deeds and/or
16 grants conveying to the Housing Authority may be accepted for and on behalf of the Housing
17 Authority by its Executive Director or by the City of Riverside's Assistant City Managers, Deputy
18 City Managers, or the Community & Economic Development Director, and that the written
19 acceptance of such deeds or grants by the Executive Director, Assistant City Manager, Deputy City
20 Manager or the Community & Economic Development Director on behalf of the Housing Authority
21 shall also constitute the consent of the Housing Authority to the recordation of such instruments.

22 Section 2: The Secretary of the Housing Authority, upon adoption of this Resolution, is
23 hereby authorized and directed to transmit to the County Recorder of Riverside County, a certified
24 copy of this Resolution for recordation in the office of said County Recorder.

25 Section 3: Section 7 of Resolution No. 2 is hereby repealed in its entirety.
