

1 RESOLUTION NO.

2 A RESOLUTION OF THE PARKING AUTHORITY OF THE CITY OF
3 RIVERSIDE, CALIFORNIA, AUTHORIZING THE CITY MANAGER,
4 ASSISTANT CITY MANAGERS, DEPUTY CITY MANAGERS AND THE
5 COMMUNITY & ECONOMIC DEVELOPMENT DIRECTOR OF THE
6 CITY OF RIVERSIDE TO ACCEPT CONVEYANCES TO THE PARKING
7 AUTHORITY OF INTERESTS IN REAL PROPERTY AND CONSENT TO
8 THE RECORDATION OF SUCH INSTRUMENTS; AND REPEALING
9 RESOLUTION NO. 28.

10 WHEREAS, on September 6, 2005, the Parking Authority of the City of Riverside adopted
11 Resolution No. 28 authorizing the City Manager, Assistant City Managers, Development Director or
12 the Real Property Manager of the City of Riverside ("City") to accept for and on behalf of the
13 Parking Authority, all deeds or grants conveying any interest in real property to the Parking
14 Authority, including the recordation of the same; and

15 WHEREAS, the Development Department has since merged into the Community &
16 Economic Development Department; and

17 WHEREAS, the Parking Authority desires to revise the authority for the continued smooth
18 acceptance of real property interests and the recordation of the same.

19 NOW, THEREFORE, BE IT RESOLVED by the Parking Authority of the City of Riverside,
20 California, as follows:

21 Section 1: That from and after the date of adoption of this Resolution, all deeds and/or
22 grants conveying to the Parking Authority may be accepted for and on behalf of the Parking
23 Authority by the City of Riverside's City Manager, any of its Assistant City Managers or Deputy
24 City Managers, or the Community & Economic Development Director, and that the written
25 acceptance of such deeds or grants by the City Manager, Assistant City Manager, Deputy City
26 Manager or the Community & Economic Development Director on behalf of the Parking Authority
27 shall also constitute the consent of the Parking Authority to the recordation of such instruments.

28 Section 2: The Secretary of the Parking Authority, upon adoption of this Resolution, is
hereby authorized and directed to transmit to the County Recorder of Riverside County, a certified
copy of this Resolution for recordation in the office of said County Recorder.

Section 3: Resolution No. 28 is hereby repealed in its entirety.
