ORDINANCE NO.

AN ORDINANCE OF THE CITY OF RIVERSIDE, CALIFORNIA AMENDING SECTION 10.76.020 OF THE RIVERSIDE MUNICIPAL CODE DESIGNATING THE ALLEY LOCATED BETWEEN ORANGE STREET AND THE MAIN STREET PEDESTRIAN MALL AS ONE-WAY NORTHBOUND TRAVEL FOR THE PORTION OF THE ALLEY LOCATED NORTH OF THE IMPERIAL HARDWARE LOFTS ENTRANCE DRIVEWAY.

The City Council of the City of Riverside does ordain as follows:

<u>Section 1</u>: Section 10.76.020 of the Riverside Municipal Code designation one-way streets and alleys is hereby amended to designate the alley between Linden Street and Fifth Street from two-way traffic operations to one-way eastbound travel only and which added portion of Section 10.76.020 is hereby amended as follows:

"10.76.020 One-Way streets and alleys. In accordance with Sections 10.28.020 and when property signposted, traffic shall move only in the direction indicated upon the following streets or portions of the streets, or alleys or portions of alleys:

Alley running north-south Between Brockton Avenue and Chestnut St.	Ninth St. and Tenth St.; Tenth St. and Eleventh St.	Northbound

Alley running north-south between Orange Street and the Main Street Pedestrian Mall

Morthbound University Avenue, beginning north of the Imperial Hardware Lofts entrance driveway

Section 2: The City Council has reviewed the matter and, based upon the facts and information contained in the staff reports, administrative record, and written and oral testimony, hereby finds that this ordinance is not subject to CEQA pursuant to Sections 15060(c)(2), 15060(c)(3) and/or 15061(b)(3) of the State CEQA Guidelines, California Code of Regulations, Title 14, Chapter 3, in that it will not result in a direct or reasonably foreseeable indirect physical change in the environment nor have a significant impact on the environment.

1	Section 3: The City Clerk shall certify to the adoption of this ordinance and cause		
2	publication once in a newspaper of general circulation in accordance with Section 414 of the		
3	Charter of the City of Riverside. This ordinance shall become effective on the 30th day after the		
4	date of its adoption.
