#### **APPROVAL OF MINUTES**

##### **CASS STREET – ESTABLISHMENT OF PREFERENTIAL PARKING ZONE (PPZ)**

Following discussion motion was made by Member Sheth and seconded by Vice Chair Armas recommending that the Transportation Board recommend that the City Council approve establishment of a “No Parking between the hours of 5:00 p.m. to 7:00 a.m. Monday through Friday except holidays, with Preferential Permit Parking for residents” zone on both sides of Cass Street from Polk Street to Lively Street.

##### **FIFTH STREET – ESTABLISHMENT OF PREFERENTIAL PARKING ZONE (PPZ)**

Following discussion motion was made by Member Sheth and seconded by Member Soza recommending that the Transportation Board recommend that the City Council approve establishment of a “2 HR Parking between the hours of 9 a.m. to 5 p.m. Monday through Friday, except holidays, with Preferential Permit Parking for residents” zone on both sides of Fifth Street between Locust Street and Brockton Avenue.

Motion carried unanimously.
