

RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING THE LAND USE DESIGNATION OF THE RIVERSIDE GENERAL PLAN 2025 AS TO THE VACANT LAND KNOWN AS THE EXCHANGE PROJECT, LOCATED ADJACENT TO ORANGE STREET AND STRONG STREETS, THE STATE ROUTE 60 AND INTERSTATE 215, FROM THE MDR - MEDIUM-DENSITY RESIDENTIAL AND O - OFFICE LAND USE DESIGNATIONS AND PLACING IT IN THE MU-U - MIXED USE URBAN LAND USE DESIGNATION AND C - COMMERCIAL LAND USE DESIGNATION.

WHEREAS, an application was submitted to the City of Riverside designated as Planning Case No. P18-0091, to amend the Land Use Designation of the Riverside General Plan 2025 ("General Plan Amendment") as to the vacant land known as the Exchange Project, by removing them from the MDR - Medium-Density Residential and O - Office land use designations and placing it in the MU-U - Mixed Use Urban land use designation and C - Commercial land use designation; and

WHEREAS, the Planning Commission of the City of Riverside, California, advertised for and held a public hearing on March 21, 2019, to consider the General Plan Amendment and recommended to the City Council that the General Plan Amendment be approved; and

WHEREAS, the City Council of the City of Riverside advertised and held a public hearing on June 4, 2019, to consider Planning Case No. P18-0091; and

WHEREAS, the City Council received and considered the reports and recommendation from the Planning Commission and all other testimony, whether written or oral, presented at the public hearing.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, as follows:

Section 1: The above recitals are hereby incorporated as if set forth herein in full.

Section 2: It is in the public interest to amend the Land Use Designation of the Riverside General Plan 2025 as more particularly described below.

Section 3: The Land Use Designation of the Riverside General Plan 2025 is hereby amended by removing the vacant land known as the Exchange Project, from the MDR - Medium-Density Residential and O - Office land use designations and placing it in the MU-U - Mixed Use

1 Urban land use designation and C - Commercial land use designation, all as described and depicted in  
2 Exhibit "A" attached hereto and incorporated herein by this reference.

3 Section 4: An Environmental Impact Report was prepared in connection with this action  
4 and has been certified concurrently with this action.

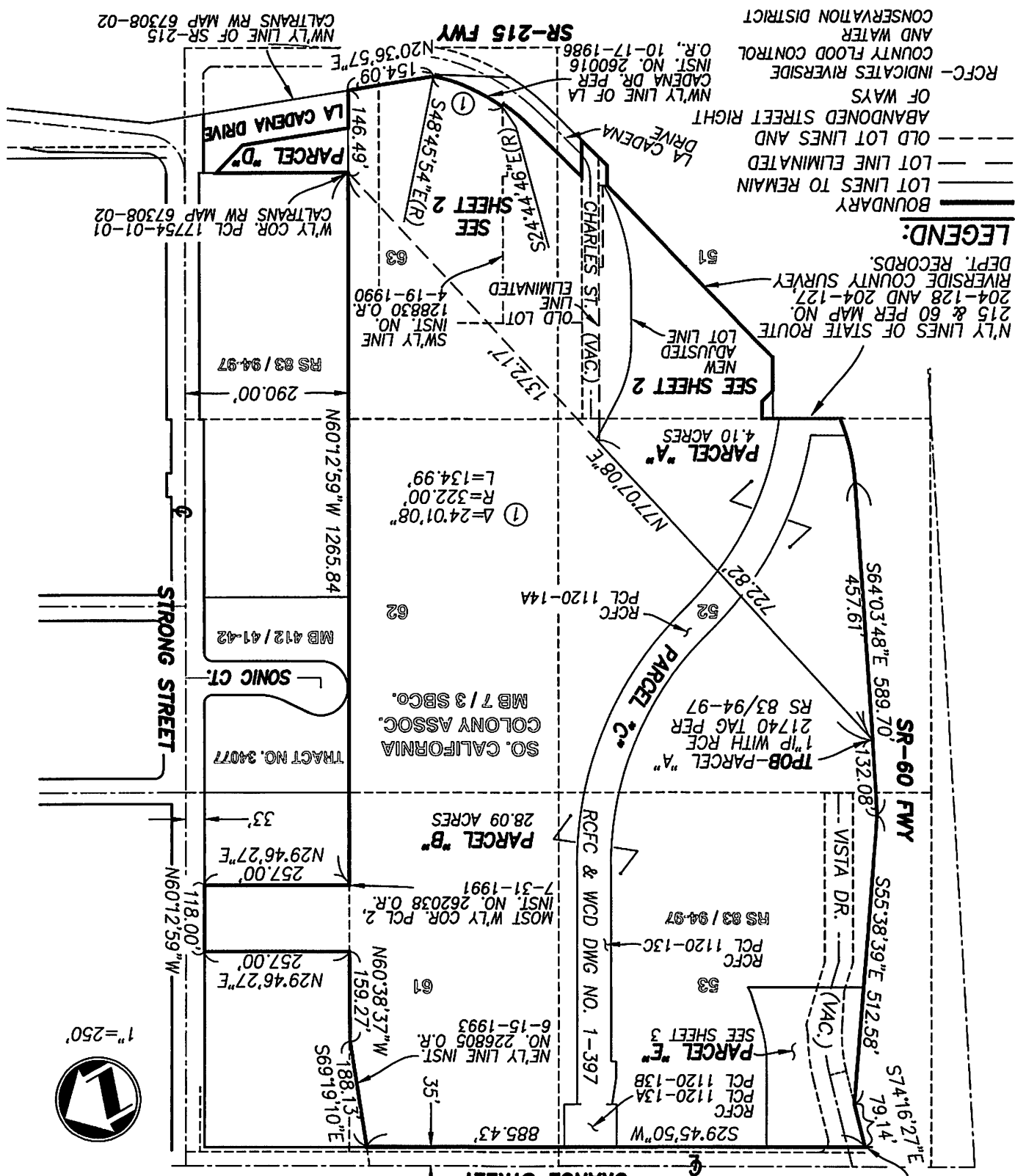

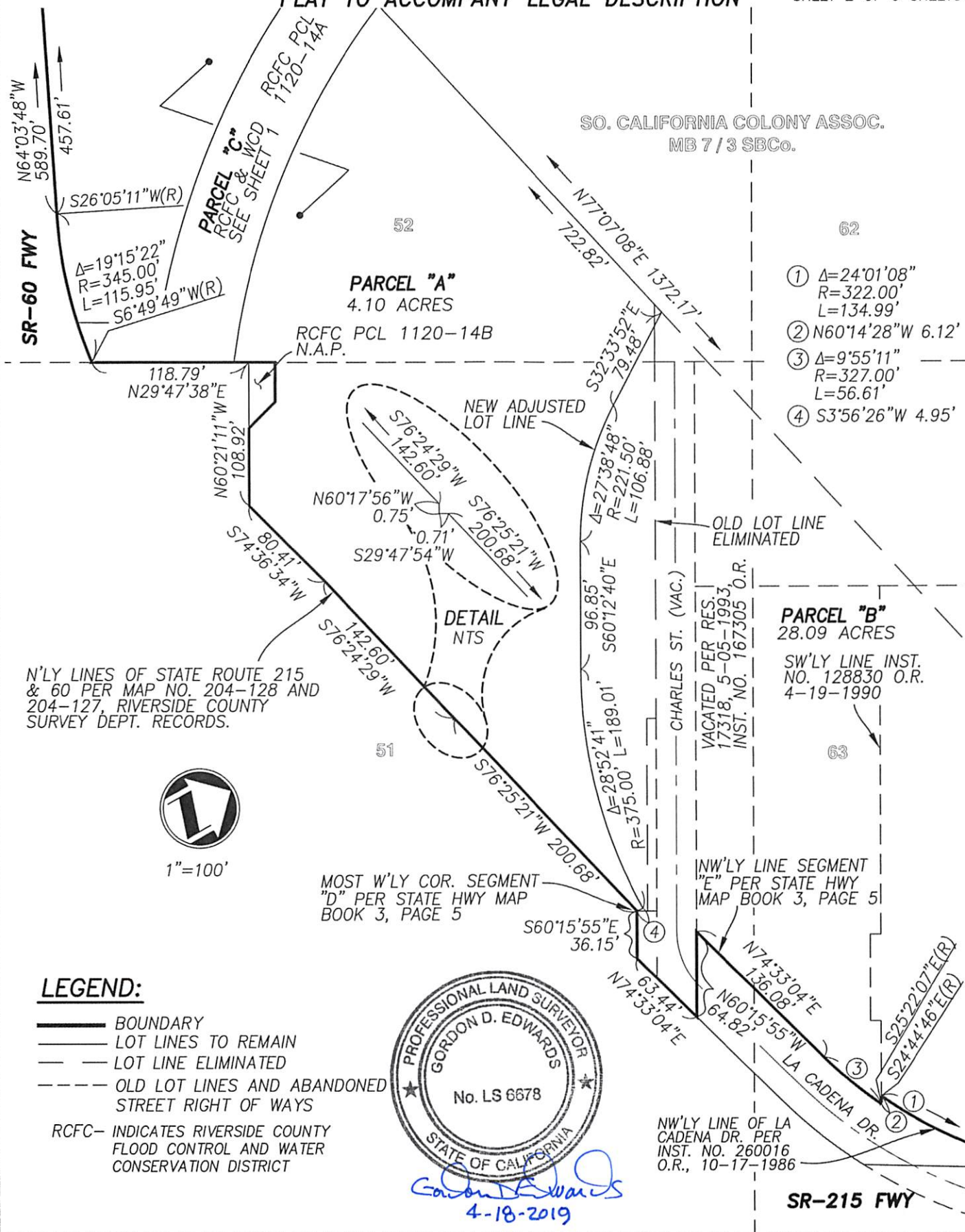
